


This monthly progress report (MPR) summarizes environmental restoration activities conducted by the U.S. Department of the Navy (Navy) at Hunters Point Shipyard (HPS) during April 2006. This MPR is prepared in accordance with the HPS Federal Facility Agreement, Section 6.6. The MPR is presented in three sections. 1.0 PARCEL UPDATES

This section summarizes key activities at each parcel completed during the past month and activities planned for the upcoming two months.



Hunters Point Shipyard

1.1 PARCEL B

The activities completed during April 2006 and planned for the upcoming two months at Parcel B are summarized below.

April 2006 Activities at Parcel B

- Continued groundwater sampling in accordance with the Parcel B Remedial Aciton Monitoring Plan (RAMP). Continued developing quarterly groundwater monitoring reports.
- Prepared and submitted the Final Storm Drain and Sanitary Sewer Removal Design Plan.

May and June 2006 Activities at Parcel B

- Begin radiological removal action of sanitary and storm drain lines.
- Continue groundwater sampling in accordance with the Parcel B RAMP.
 Continue developing and submitting quarterly groundwater monitoring reports.
- Begin responding to agency comments on the draft Technical Memorandum in Support of a Record of Decision Amendment.
- Submit investigation report for groundwater and soil gas at the Parcels B and C boundary.

1.2 PARCEL C

- Continued to prepare the draft Revised Feasibility Study Report for Parcel C.

- Respond to any comments on the draft work plan for a groundwater treatability study at Building 253, remedial unit (RU)-C1, submit final Work Plan and initiate the Treatability Study.
- Continue groundwater sampling in accordance with the SAP for Basewide Groundwater Monitoring. Continue developing and submitting quarterly groundwater monitoring reports.
- Continue to prepare the draft Feasibility Study Report for Parcel C.

1.3 PARCEL D

- Continued to prepare the draft final Revised Feasibility Study Report for Parcel D.
- Continued groundwater sampling in accordance with the SAP for Basewide Groundwater Monitoring. Continued developing and submitting quarterly groundwater monitoring reports.

- Continue to prepare the draft final Revised Feasibility Study Report for Parcel D.
- Continue groundwater sampling in accordance with the SAP for Basewide Groundwater Monitoring. Continue developing and submitting quarterly groundwater monitoring reports.
- Perform radiological survey of Building 813.

1.4 PARCEL E

- Continued soil screening and site restoration at the metal reef removal action area in accordance with the work plan.
- Continued implementing the Installation Restoration (IR)-02 Northwest and Central removal action in accordance with the work plan. Work resumed at a higher level of activity with the improvement in weather.
- Continued to prepare the draft Wetlands Mitigation Plan to restore areas affected by the Parcels E and E-2 removal actions.
- Continued to prepare the revised draft Remedial Investigation Report for Parcel E.
- Continued groundwater sampling in accordance with the SAP for Basewide Groundwater Monitoring. Continued developing and submitting quarterly groundwater monitoring reports.

- Prepare and submit the responses to comments on the Parcel E and E-2 Shoreline Technical Memorandum.
- Continue groundwater sampling in accordance with the SAP for Basewide Groundwater Monitoring. Continue developing and submitting quarterly groundwater monitoring reports.
- Continue to prepare the revised draft Remedial Investigation Report for Parcel E.

1.5 PARCEL E-2

The activities completed during April 2006 and planned for the upcoming two months at Parcel E-2 are summarized below.

- Continued site restoration at the metal slag removal action area in accordance with the work plans.
- Continued groundwater sampling in accordance with the SAP for Basewide Groundwater Monitoring. Continued developing and submitting quarterly groundwater monitoring reports.
- Continued monthly landfill gas monitoring. Prepared and submitted monthly landfill gas reports.
- Continued to prepare the draft Remedial Investigation/Feasibility Study Report for Parcel E-2.
- Resumed excavation and field activity at the Polychlorinated Biphenyl (PCB) Hot Spot Area.
- Recorded monthly visual observations of storm water at the landfill during rain events.

May and June 2006 Activities at Parcel E-2

- Continue monthly landfill gas monitoring. Continue to prepare and submit monthly landfill gas monitoring reports.
- Continue site restoration at the metal slag removal action area in accordance with the work plans.
- Continue field activities for the shoreline removal action areas. Continue excavation at the PCB Hot Spot Area.
- Continue groundwater sampling in accordance with the SAP for Basewide Groundwater Monitoring. Continue developing and submitting quarterly groundwater monitoring reports.
- Continue to prepare the draft Remedial Investigation/Feasibility Study Report for Parcel E-2.
- Record monthly visual observations of storm water at the landfill during rain events.
