1.0 PARCEL UPDATES

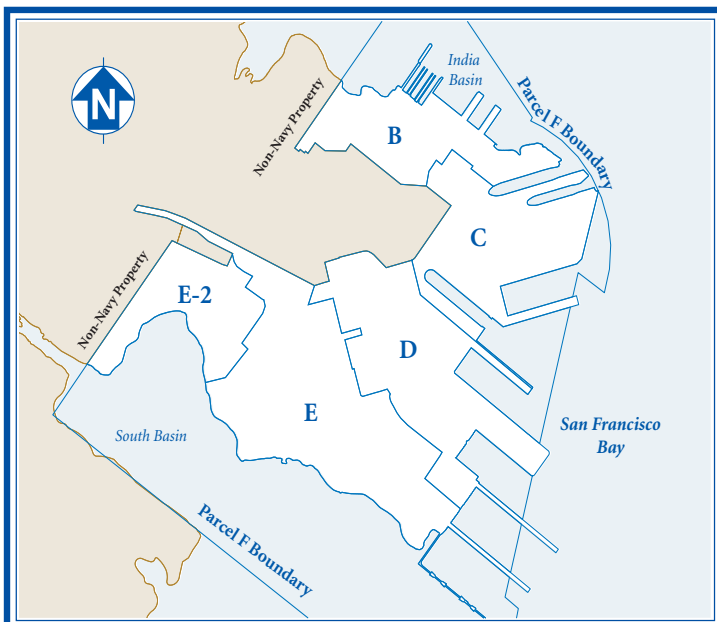
This section summarizes key activities at each parcel completed during the past month and activities planned for the upcoming two months.

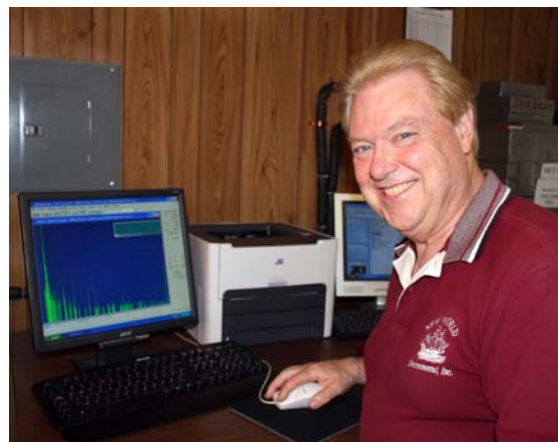
- Submit the annual update to the Storm Water Discharge Management Plan.
