



2 CONS Spend Analysis (FY10)








Socio-economic Performance





Federal Acquisition Regulation Requirements




- All requirements >\$10K are posted via <u>www.FedBizOpps.gov</u> (LA Government Procurement Center)
 - Non-commercial (synopsis + solicitation)
 - Commercial (combined synopsis/solicitation)
- Ability One (NIB/NISH)
 - Javits-Wagner-O'Day Act requires the Gov't to purchase supplies and services from Ability One non-profit agencies (FAR 8.704)
 - Custodial, telephone switchboard service, laundry (base and hospital), and operation of postal service center
- Section 8(a) Business Development Pgm
 - Sole source authority <\$4M (FAR 19.805-1(a)(2))</p>
 - "Special Notice" release intent of future 8(a) awards (fedbizopps)/2 CONS website
