# DFMWR RESALE LOT PARKING PERMIT

PLEASE KEEP YOUR AREA COMBAT PROUD

Utilization of the Resale Lot is open to all USAG Wiesbaden active duty Military, DoD Civilians, NAF Personnel, NATO ID holders and US Retired Military (space available). Priority for use will be given to Active Duty, DoD Civilian, and NAF assigned to the USAG Wiesbaden area of responsibility. At peak PCS periods, priority will be given to Active Duty and DoD civilians with PCS orders; all others may be placed on a waiting list.

**DUE TO LIMITED PARKING SPACES,- PERMIT IS NON-RENEWABLE UNLESS SPACE IS AVAILABLE!**

1. Vehicles must be registered and insured. The vehicle registration expiration date must exceed the Resale Lot Permit expiration date.
2. **This Resale Lot Permit must be prominently displayed on the dashboard of the vehicle.** Vehicle owners must maintain registration for the duration the vehicle is in the lot. Permit fee is \$30 for 30 days. A 30 day extension may be obtained for an additional \$30 fee. You may be required to sign a waiting list if the lot is full.
3. Use of the lot is for private sales only. No commercial sales operations are allowed.
4. The resale lot will not be used for long term storage of vehicles.
5. Vehicles with an expired permit or no permit (abandoned property) will be removed at the owner's expense to the military police impound lot. Abandoned vehicles will become the property of the MWR Donation Auto system and be subject to disposal IAW DOD Regulation 4160.21, paragraph 56.
6. Use of the lot is a privilege, not an entitlement. Violations of the user policy will result in termination of the permit, removal of the vehicle and disciplinary action as the Command dictates.
7. Spaces are assigned to you and are numbered along the curb – DO NOT PARK in another site.

\*\*\*The Directorate of Family, Moral and Welfare is NOT responsible for any loss or damage to vehicles as a result of being parked in the Base Resale Lot. Only one non-transferable permit is authorized per vehicle.
