**Crab Fishing Year 2010-2011**

Dear Vessel Owner(s):

Enclosed is your Federal Crab Vessel Permit (FCVP). A copy of this permit must be on board any vessel used to fish in the rationalized crab fisheries, and must be available for inspection at any time by an authorized officer. This permit may not be surrendered during the crab fishing year for which it is issued. However, if the vessel is sold during the year the permit is invalid and new owners will have to obtain a new vessel permit.

In addition to this Permit, other requirements pertain, as follows:

**Vessel Monitoring System (VMS)**

Any vessel used to harvest crab in the rationalized crab fisheries must have a functioning VMS transmitter on board. The VMS must be transmitting when the following three conditions are met:

1. The vessel is operating in any reporting area off Alaska; and,
2. The vessel has crab pots or crab pot hauling equipment, or a crab pot launcher onboard; and,
3. The vessel has (or is required to have) a FCVP.

**Logbooks**

The operator of a vessel operating in the BSAI crab fisheries must maintain the appropriate logbooks and make them available for inspection at any time by an authorized officer. The required logbooks include:

- The Daily Fishing Log (DFL), which must be maintained by the operator of a catcher vessel using pot gear to harvest CR crab from the BSAI; and,
- The Daily Cumulative Production Log (DCPL), which must be maintained by the operator of a catcher/processor vessel using pot gear to harvest CR crab from the BSAI.

The appropriate logbooks are included with this mailing of your FCVP. Please note that you are being sent logbooks from our current supply of groundfish logbooks. You can use these logbooks to record your BSAI crab harvests by writing "CRAB" over one of the other columns on the appropriate pages. Economic Data Report

50 CFR 680.6 requires that the owners or leaseholders of any vessel that landed crab in the CR crab fishery submit an annual Economic Data Report (EDR). The EDR requires that Alaska Department of Fish and Game (ADF&G) fish ticket numbers and landings data be provided. State of Alaska confidentiality laws provide that fish ticket information may only be released to the person named on the State permit identified on the fish ticket. We recommend that you obtain a waiver of confidentiality from each of your crew members, and copies of completed fish tickets to assist you in complying with federal EDR requirements. Also enclosed is a checklist of various requirements for catcher-vessels or catcher-processor vessels operating in the BSAI crab rationalization fisheries.
