## North Dakota State Advisory Committee to Convene Briefing and Listening Meeting on Civil Rights Issues in the State

FARGO, ND -- The North Dakota State Advisory Committee to the U.S. Commission on Civil Rights will convene a briefing and listening meeting to discuss and hear comments from local and community organizations, local and state agencies, and the public on civil rights issues in the state. This will be the first of a series of meetings to be held around the state.

The State Advisory Committee will hear from the North Dakota Human Rights Coalition about its activities and the civil rights issues it identifies as important.
