What is the BDD Claim at Fort Bragg?

A BDD claim is a specific type of pre-discharge claim that is taken from a service member on active duty and processed at the Fort Bragg office. In order for a claim to be processed as a BDD claim, service members must have no less than 60 days remaining on active duty (or 60 days Prior to Terminal or Permissive Leave) and must be available to attend all required examinations that are scheduled through this office.

What if I have less than 60 days remaining on active duty?

If you have less than 60 days remaining on active duty, you may file a different type of predischarge claim called a Quick Start claim. The entire claims packet is accepted at this office, but transferred to the Winston-Salem Quick Start Consolidated Processing Site for processing.

What you need to do prior to coming to this office:

Attend the VA Entitlement Benefits Briefing on Thursdays <u>and</u> the VA Claims Briefing on Fridays. Both of these take place in the DHR Multi-Media Classroom (F-100) on the 1st floor of Soldier Support Center (Old Womack) at 9:00. The briefings will be held every Thursday and Friday except for Training Holidays or Federal Holidays.

Also, you will need to bring:

- ✓ Completed VA form 21-526
- ✓ Service Treatment Records (a complete and legible copy)
- ✓ Marriage License (Copy)
- ✓ Divorce Decree (Copy)
- ✓ Social Security Numbers for all Dependents
- ✓ Birth Dates for all Dependents
