


CLOUTER CREEK DISPOSAL AREA

- Approximately 1400 acres subdivided into four "cells".
 - ► Northern third is owned by the South Carolina State Ports Authority (SCSPA).
 - ► Southern two-thirds of the area (formerly owned by the U.S. Navy) are now owned by the Corps of Engineers.
- ■The Federal Government enjoys a perpetual easement on the state-owned portion.




CLOUTER CREEK DISPOSAL AREA

CCDA STATUS

- ► All Private Material Successfully Placed
- ► North Cell Ditching Contract Starts September 2012
- ► Highway Cell Repair Starts September 2012
 - Ready for use January 2013
- ► Middle Cell In Use-Upper CHS Contract
 - Closes for drying/ditching Early 2013
- ► South Cell In Use-Upper CHS Contract
 - Currently in use
 - OUT OF USE 2017

 - ➤ South Cell 150,000 CY

CCDA FUTURE

- North/Middle Cells
 - ▶ Ditching 2012-2015
 - ▶ Diking Cycle 2015-2016
 - ► Ready for use by early 2016
- Highway/South Cells
 - ▶ 2 Cycles of Ditching 2017-2018
 - ▶ Diking Cycle 2019-2020
 - ► Ready for use 2021

- ■Federal Channel (Upper Harbor) Fall 2012/3-CCDA
- ■Federal Channel (Lower Harbor) Summer 2013-OFFSHORE



PERMITS/CONSENT AGREEMENTS

- CCDA Disposal Fee Increase
- Time Frame
 - ▶ 1 Aug 2010-1 Nov 2012 Lowered
 - ▶ 2 Nov 2012 reverts back to \$.51 USACE/\$.74 SCSPA
- Disposal Fee is \$.51 to USACE
- Disposal Fee to SCSPA is \$.74
 - ▶ Make Check out to South Carolina State Ports Authority
 - ▶ Where do you send it to?

POST 45 FEASIBILITY STUDY

- Funding Availability is not currently a constraint on progress
- Feasibility Study has been rescoped and will be complete by President's target of September 2015 (We Can't Wait Initiative) for a cost under \$13M
- Multiple contract awards for data collection and analysis will be made in August 2012
- Numerical modeling, environmental sediment sampling, and cultural/historic resource surveys



Way Ahead

- Users Provided with updated 5 Yr Plan
- Check Permit Expiration Date
- Consent Agreement Submission Process
 - ▶ 1/2 up Front Balance at the END
- Reevaluate Disposal Fees
- Keep Established Lines of Communication Open
