Secure Communities

Secure Communities is U.S. Immigration and Customs Enforcement's (ICE) comprehensive strategy to improve and modernize the identification and removal of convicted criminal aliens from the United States. As part of this strategy, ICE is leveraging a federal biometric information sharing capability to quickly and accurately identify aliens in law enforcement custody. Once identified, ICE prioritizes convicted criminal aliens for removal from the United States. ICE is also conducting modeling and analysis of the current criminal alien enforcement process to ensure the right people, resources and processes are in place to make immigration enforcement more efficient and effective.

The National Sheriffs' Association, Major County Sheriffs' Association, the New York State Sheriffs' Association and the New York State Association of Chiefs of Police have all issued formal statements in support of Secure Communities.

"Before, we had people that were in our jail that had several aliases. We didn't know who they were. Sometimes they have 12 names, different Social Security numbers. They can't fudge or fake that fingerprint. That fingerprint detects—tells us who they are, tells ICE who they are. [...] And [Secure Communities is] actually here to deport and make arrests on criminal aliens, people who have come here illegally and have committed a crime or have a criminal history." ¹²

"There are no community divisions being created with this program...We are not going out into the community seeking illegal aliens. No one is sought out, and no one is fingerprinted other than criminals processed into our jail." ¹³

"[Secure Communities] does draw that bright line between the federal role and the local role in immigration enforcement....
