Baseline study to illuminate current safety culture and knowledge of FMCSA

Study of uniform CMV definition

Study to investigate how to improve the quality of data including driver/carrier transparency, sharing of data, etc.

Synthesis study on shipper, broker and other industry responsibilities and incentives

Study on distracted driving, focusing on what causes distracted driving

Synthesis study on safety of retreaded, recapped, and re-grooved tires on commercial motor vehicles

Two recommendations were tabled for further discussion at upcoming meetings (study of roles and responsibilities of agencies related to motor carrier security and pre-operating authority). Two recommendations had annotations identifying concerns from Ms. Stone and Mr. Spencer (offering tax credits to carriers for utilizing safety technology and carriers implementing safety technologies in lieu of fines). The 09-01 report was unanimously adopted pending the above changes to the report.

TASKING: The Committee unanimously accepted Task 09-02: "Provide advice and guidance to FMCSA on the essential elements that the Agency should include when drafting new proposed legislation to permit Mexico-domiciled trucks beyond the current commercial zones along the U.S.-Mexico border."

PUBLIC COMMENT PERIOD: The public comment period was scheduled for 3:00 pm; however, no member of the public signed up to provide comments.

ADJOURNMENT: The meeting was adjourned by the DFO at 3:15 pm on March 18, 2009.
