## WIRELESS TELECOMMUNICATIONS BUREAU ANNOUNCES IT IS PREPARED TO GRANT LOWER 700 MHZ BAND LICENSES UPON FULL AND TIMELY PAYMENT

### AUCTION 44

#### Report No. AUC-44 (Auction 44)

On September 18, 2002, the Federal Communications Commission completed the auction of 740 licenses in the lower 700 MHz C and D blocks.<sup>1</sup> The application included on this public notice was listed as accepted for filing on a public notice released in 2010.<sup>2</sup>

By this Public Notice, the Wireless Telecommunications Bureau announces that it is prepared to grant the application for the licenses listed in Attachment A to this Public Notice, upon the full and timely payment of the remaining balance of each applicant's winning bid(s). Such payment must be received by the Commission within ten (10) business days after the date of this Public Notice (*i.e.*, by **January 31, 2013**). *See* 47 C.F.R. § 1.2109(a). If the winning bidder listed in Attachment A fails to pay the balance of its winning bid in a lump sum by **January 31, 2013**, it may pay the remaining balance within ten (10) business days after the payment deadline (*i.e.*, by **February 14, 2013**), provided that it also pays a late fee equal to five percent of the amount due. *See* 47 C.F.R. § 1.2109(a).

A winning bidder listed in Attachment A that fails to pay the balance of its winning bid(s) by the late payment deadline of **February 14, 2013**, will be in default and subject to applicable default payments. *See* 47 C.F.R. §§ 1.2104(g), 1.2109(c). Such applicant will be assessed default penalties as prescribed by sections 1.2104(g) and 1.2109(c) of the Commission's rules. *See* 47 C.F.R. §§ 1.2104(g), 1.2109(c).

#### Payment Instructions

All payments must be made in U.S. currency in the form of a wire transfer. *See* 47 C.F.R. § 1.2107(b). No personal checks, cashier's checks or other forms of payment will be accepted.

Down payments and final payments must be preceded by an accurate and complete FCC Remittance Advice Form (FCC Form 159). At least one hour before placing the order for the wire transfer (but on the same business day), the winning bidder must fax the completed FCC Form 159 to

U.S. Bank in St. Louis, Missouri, at (314) 418-4232. Proper completion of the FCC Form 159 is critical to ensuring correct credit of a winning bidder's deposits. Each winning bidder must use in its FCC Form 159 the same FCC Registration Number (FRN) used for the applicant in the applicant's short-form application (FCC Form 175).
