

INFORMATIONAL RESPONSE TO WORKERS COMPENSATION FILE NUMBER A6-411601 LETTER DATED 19 MARCH 1987

- 1. Mr. Peterson performs supervisory duties of lower level civilian employees and military personnel in carrying out an intergated multiple-use program of fish and wildlife conservation for Marine Corps Base, Camp Lejeune, North Carolina. Non-supervisory administrative duties are: (a) Develops and updates the following programs: 1) Game Species Management, 2) Nongame Species Management, 3) Endangered and Threatened Species Management, 4) Control of Base Wildlife Populations and 5) Archaeological/Historical Resources Protection. (b) Provides fish and wildlife conservation services to the civilian and military workforce of the base. A further breakdown of Mr. Peterson's duties are described in paragraph 9 below.
- a. Mr. Peterson expends, approximately, 80% of his work time in the office of Natural Resources and Environmental Affairs Division, Building 1103, Industrial Area, Marine Corps Base, Camp Lejeune, North Carolina. Mr. Peterson also visits various Camp Lejeune military training areas from time to time relative to his responsibilities in carrying out the duties of the position. While in the training areas there may be unexpected explosive sounds from artillery, tanks, exploding ordinance, jet aircraft, and helicopters. Mr. Peterson has hearing protection devices including ear plugs and sound muffs in his possession which are available for use when expected hazardous noise may be encountered.
- b. The decibel level for the Homelite Chainsaw, serial number 312927 which is currently on Account Number 28, Mr. Peterson's Supply List, measures ______, and is the same chainsaw used when the pond area was cleared.
- c. Mr. Peterson states that he was the primary operator of the subject chainsaw which was used to clear brush from Hickory Pond in 1968.
 - d. July August 1968, 6 hours per day, 5 days per week.

- 4. The employee is verbally notified by the audiogram technician/civilian health nurse through the review of the written results of the audiogram when hearing loss is indicated.



- 5. Supervisors were instructed after the hearing conservation program was initiated to procure hearing protection devices for themselves and all their employees at the Self Service Issue Point. Mr. Peterson has purchased both ear plugs and sound muffs for himself and each employee he supervises as instructed. Such hearing devices are always available to him and his employees.
- 6. The employee was not notified of the hearing loss by anyone here that it was possibly employment related.
- 7. Employee is only subjected to un-expected hazardous noise areas, does not normally operate any type of hazardous noise equipment on the job, and does not normally work in hazardous noise areas.







Frequent un-expected sounds involving artillery tanks, explosive ordinance, riding in military helicopters and jet aircraft fly-overs. Also operating outboard motors, farm tractors, and being around bulldozers. Also involved using Homelite Chainsaw, serial number 3129276, to clear fish pond known as Hickory Pond of brush in 1968. Note: Ear protectors not available through GSA System until mid 1970's. Average number of hours exposed to chainsaw per day was approximately 6 hours extending for 8 weeks during July - August 1968. Noise encountered relative to Job Duty 3, Above Less frequent un-expected sounds involving artillery, tanks, explosive ordinance, riding in military helicopters, and military jet aircraft fly-overs. Note: Hearing protection devices are now available, required and are used by me when around expected noise which requires the use of such devices. Unexpected explosion of high-explosives at Wilkins Bluff, which occurred on 26 March 1987 while I inspected wildlife planting at TLZ Canary. 5. No past history of any ear problems except loss of high frequency hearing, which employee strongly believes were caused by using the subject chainsaw to clear the subject fish pond. 6. Sometime during late 1970's when all supervisors were instructed to purchase ear plug devices from the Self-Service Section for the supervision and each employee. When I became aware that hearing protection muffs available in the Self-Service Section in 1985, I voluntarily purchased a set for myself and each of my employees. For my personal hearing protection. 8. No. 9. I was very fortunate for having a healthly childhood as well as a healthly adult life to the present. Childhood illnesses involved minor colds which were generally treated with decongestants and occasional shots of penicilling by my family doctor. 10. I use a 10 hp. riding lawn mower on my lawn, but only when wearing hearing protectors.


