Fred,

I have talked with Bill Harvey and Rivers and Associates folks regarding well sites on the base. There is potential for the county to install wells between Highway 210 and Verona Loop Road without affecting our new wells in the Camp Devil Dog area. Only one of the five new wells is on-line, and it is producing around 600 gpm. The potential sites for the county should be located well south of these. The only site conflict I foresee at this time is location of the Rifle Range Wastewater force main. Precautions will have to be taken to prevent damage to it dependent upon location of the well sites and access roads.

Water production and source requirements will be investigated in the initial study of a joint utility authority.

My recommendation is to meet with the county to discuss further. There is a definite possibility of joint benefit. We may need to include environmental and real estate folks and ensure that all parties understand all

expectations and responsibilities. Unless GSRA water requirements should significantly increase, I do not foresee the area that the county is considering being a future groundwater well field for the base.
