Training

All Police Officers for all positions undergo 8 weeks of training in a Marine Corps Police Academy at the hiring installation. The course prepares the Police Officer to become a valued member of the team at the assigned installation. Police Officers undergo refresher training periodically to maintain proficiency in required skills like weapons qualification. Those selected for specific positions will attend other training such as Special Reaction Team Training, Physical Security School, Investigation Courses, Working Dog School, and Traffic Accident Investigation School.

The Marine Corps initiated a Civilian Police force in 2005 and established Marine Corps Police Departments in Albany, GA; Jacksonville, FL; and Barstow, CA. The new police officer hires will be spread across four years with a target of hiring 400 police officers in FY08, 300 in FY09–10, and 182 in FY11. Police Officers will be working side-by-side with Marine Corps Military Police at Marine Corps installations across the United States.
