Retiree Appreciation Day 2009

24 October 2009 Registration 0700/Opening Ceremony 0800

Come by and get your Retiree Appreciation Package!

It is said that success breeds success. This is especially true when it comes to Fort Campbell Retiree Appreciation Day (RAD). Since the current Retirement Services Office began conducting RADs in 2007, the event has gotten better each year and has grown in popularity. The RAD for this year promises to continue on the same path.

This year the event will be held on 24 October 2009 from 0700 to 1600 at the Passenger Processing Center (PPC) on Campbell Army Airfield, the same location as last year. The event in October is going to keep the best things from past RADs, and will have some changes that will make it even more enjoyable and convenient. All resources and organizations other than the ID Cards section will be located at the PPC under one roof (The ID Card office in Bldg 2577a will be open from 0800 to1600).

At registration, all Retirees will receive a Retiree Appreciation Package consisting of a large coffee mug, Army Retiree decal, Army Retiree Pin, Retirement Services Office magnet, and more! The mugs are over-sized and were made specifically for the RAD with the Army Retired logo in full color.

The Guest Speaker will be Retired Major General William Matz, President of the National Association of Uniformed Services (NAUS), a major presence on Capitol Hill lobbying on the behalf of all veterans. Let there be no doubt that benefits afforded Retirees for their years of service and hardship are under attack by many on Capitol Hill. Organizations such as the NAUS play an important role on behalf of Retirees, fighting for the benefits that you earned.

Blanchfield Army Community Hospital will sponsor a health fair to provide preventive health, dietary, height/weight, blood pressure screenings and other valuable information related to your health. Pneumonia and Influenza vaccinations will be available for Retirees and spouses, as well as Shingles vaccinations.

The 101st Airborne Division (AASLT) will provide numerous static displays manned by Soldiers recently returned from a tour of combat duty in Iraq and/or Afghanistan. Displays will include: Rifle Squad with equipment, all three mortar systems with crews, 105mm Howitzer with crew, combat medic with equipment, and a tactical communications specialist with equipment. Come by and see the changes to equipment you used when you were on duty.

And if these are not enough reasons to attend, there will be a special tour of Fort Campbell after the door prize give-aways including an Air Assault demonstration at Sabaulaski Air Assault School, a visit to Pratt Museum and an opportunity to familiarize with current small arms weapons at the Engagement Skills Trainer (EST). The EST is how today's Army trains with weapons and allows small units the opportunity to work on marksmanship skills and fire team coordination. The EST allows Soldiers to fire replica weapons at realistic target scenarios, all inside a building rather than on a range. The weapons are exactly like live fire weapons, have realistic recoil, and must be reloaded while firing. Don't miss this opportunity to fire the Army's newest weapons.

The Fort Campbell High School (FCHS) ROTC department will again provide the Honor Guard for the opening ceremony. Additionally, the FCHS Rifle Team will perform several times during the morning. These students are absolutely outstanding and not to be missed.

A US Flag flown over the Nation's Capitol (donated by Congressman Ed Whitfield) and a Sharp Aquos 40 inch, LCD, flat screen television top off the list of door prizes that will be given away after lunch. The door prize give-away will begin promptly at 1300 so don't be late! Remember, you must be present to win.

Tax Break May Be Taxing

The recently enacted economic stimulus law reduces federal income taxes up to \$400 for working individuals and \$800 for couples via smaller tax withholding from their paychecks. Non-working military retirees or survivors are not eligible for the tax reduction but still see reduced withholding in their retired pay or survivor annuities.

That's because the Defense Finance and Accounting Service (DFAS) is required to use the new tax withholding tables published by the IRS for retired paychecks or annuities arriving in bank accounts since May 1.

To add to the confusion, the stimulus bill also provides a \$250 payment to those drawing Social Security or VA disability compensation. So if a retiree or survivor draws VA disability or Social Security, he or she will get a \$250 payment on top of the reduced income tax withholding.

A working retiree who also draws Social Security or VA disability compensation will get the \$250 payment and also will have the additional \$400 less (or \$800 if married, filing jointly) withheld from both military retired pay and employer pay.

The combination of multiple withholding changes means some working retirees, especially those who have working spouses with reduced withholding in their own paychecks, may face rude awaken-

ings next spring when they discover they've been underwithheld and owe an unexpectedly large bill when filing their 2009 taxes.

Here are some examples.

-Nonworking military retirees with Social Security or VA disability compensation will get a \$250 check from Social Security or the VA and will end up having \$400 or \$800 (single or married, respectively) less withheld from their retirement checks this year but still owe that same \$400 or \$800 in full when they file taxes next year.

-Working military retirees who do not receive Social Security or VA disability compensation will have \$400 or \$800 (single or married, respectively) less withheld from both their military retired pay and their employer's pay-a total of \$800 or \$1600 less withheld, which means they'll have to pay \$400 or \$800 of that back when they file their 2009 taxes next year. (Taxpayers can only receive the tax credit once.)

-Working military retirees who receive Social Security or VA disability compensation will get the \$250 payment and also will have \$400 or \$800 (single or married, respectively) less withheld from both their retired pay and from their

employer's pay-a total of \$800 or \$1600 less withheld. However, the total tax credit they can qualify for will be \$400 or \$800, and the \$250 counts against that. So they'll end up having to pay back \$650 (single) or \$1050 (married, filing jointly) when they file their 2009 taxes next year.

Retirees who think they'll be under-withheld have several options:

Option 1- Refer to your December 2008 Retiree Account Statement for your "old" (higher) withholding amount and either:

-use the DFAS electronic MyPay option to restore your old withholding amount, or

-fill out and mail a new W-4 to DFAS that restores the old withholding.

Option 2- Submit estimated tax payments to the IRS June 15, 2009; Sept. 15, 2009; and Jan.15, 2010, with payments of \$133 or \$266 each time to make up the \$400 (single) or \$800 (married) total withholding difference.

Option 3- Do nothing. If you routinely have received federal tax refunds of \$1000 or more, DFAS' new withholding reduction shouldn't leave you owing any additional taxes on your 2009 return. The refund will be \$400 or \$800 (single or married, respectively) lower than it usually has been.

Action May Be Necessary To Keep Your Current TRICARE Benefits!

Are you TRICARE Prime to a Military Treatment Facility (MTF) and live more than 30 minutes from that

If so, you may need to sign an Access to Care waiver and have it on file with Health Net in order to continue receiving your primary care at your MTF. In order to ensure all beneficiaries receive the best care possible. The Military Health System has access to care regulations that are required by Federal Law. Where you live determines where you receive your primary care, that helps ensure that you have timely access to health care service.

TRICARE Prime enrollment requires your Primary Care Manager (PCM) be located in a TRICARE Prime Service Area (PSA) and within a 30-minute drive time of your residence. A PSA is a geographic area where TRICARE Prime is offered, typically within a 40-mile

radius of an MTF.

Does this affect me?

Only those beneficiaries and their family members who live more than 30 minutes from their assigned MTF and do not have an Access to Care waiver on file. If that's you, you will be sent a letter informing you of your options and actions you must take. You may need to submit paperwork, which can be done at your local TRI-CARE Service Center (TSC) or by mail. When do you need to take action? Any necessary action must be taken by

September 30, 2009. What happens if I don't do anything? If you do not take action, you may be reassigned to a PCM within 30 minutes of your residential address (if available) or in some cases disenrolled from TRICARE Prime. However, if you are disenrolled from TRICARE Prime, vou will still be able to receive health care vices at 1-877-TRICARE (1-877-874-

Extra, but increased out-of-pocket expenses will be incurred.

Important: Keep Your DEERS record updated!

To ensure you are receiving the best care possible, please keep your Defense Enrollment Eligibility Reporting System (DEERS) records accurate and up-to-date. To make changes to your record, visit https://www.dmdc.osd.mil/appj/address/ indexAction.do; call 1-800-538-9552 or send your changes to Defense Manpower Data Center Support Office, Attn: COA, 400 Gigling Road, Seaside, CA 93955-

Obtaining a Replacement DD Form 214

Have you lost track of your DD Form 214? Our office receives calls almost daily requesting help in acquiring a copy of this most important of all military documents. Most veterans and their next-of-kin can obtain free copies of DD Form 214 and other military and medical records. There are three relatively easy ways to accomplish this.

First, if you use the internet, go to the National Archives website at http://www.archives.gov/veterans/ military-service-records/get-Personnel Records Center has a new online ordering system called eVetRecs which allows you to create a customized order form to request information from your, or your relative's, military personnel records. You may use this system -of-kin of a deceased, former member of the US military (the next-of-kin can be any of the following: surviving spouse that has not remarried, father, mother, son, daughter, sister, or brother).

eVetRecs is a very easy process. First, click on the "Request Military Records" button to start. This will launch a separate window. Enter the required information in the system to create your customized request form. There are 4 steps that you need to navigate.

The system will guide you through the steps and tell you exactly which step you are on. Print, sign and date the signature verification area of your customized form. If you don't have a printer, have a pen and paper handy and you will be guided through the process. This is important because the Privacy Act of 1974 (5 U.S.C. 552a) requires that all requests for records and information be submitted in writing. Each request must be signed and dated by the veteran or next of kin. Mail or fax your signature verification form to the address service-records.html. The National on the print out, and your request will be processed. You must do this within the first 20 days of entering your request, or your request will be removed from the system.

The second method (for those that are not accustomed to using the internet) is to use Standard Form 180 (SFif you are a military veteran or next 180), Request Pertaining to Military Records. You can request this form by contacting the National Personnel Records Center at: National Personnel Records Center, 9700 Page Avenue, St. Louis, Missouri 63132. After completing the SF-180, mail it to the address on the form.

> The third method is to write a letter to request records. Requests must contain enough information to identify the record among the more than 70 million on file at NPRC (MPR). Certain basic information is needed to locate military service records.

This information includes: the complete name used while in the service, service number or social security number, branch of service, dates of service, date and place of birth, place of discharge, last unit of assignment, and place of entry into the service (if known). Additionally, it is extremely helpful to the staff at the NPRC if you can provide the following information: the purpose or reason for your request, such as applying for veterans benefits, gathering service documents as you prepare to retire, or researching your personal military history. Also let them know of any deadlines related to your request. The folks at NPRC will do their best to meet any priorities. For example, you may be applying for a VA-guaranteed Home Loan and need to provide proof of military service by a specific date. Any other specific information, documents or records you require from your Official Military Personnel File (OMPF) besides your Report of Separation (DD Form 214).

Use one of these three methods and you should have no problem obtaining your DD Form 214.

Identification Card Changes

Important changes have taken place regarding identification cards in the past year. As these documents play a vital role in the lives of Retirees, the changes are listed below:

Indefinite ID Cards for Permanently Incapacitated Dependents over Age 21 Real Time Automated Personnel Identification System (RAPIDS), the software used to track eligibility and issue identification cards, has undergone an upgrade that changed the way ID Cards are renewed for permanently incapacitated dependents over age 21. In the past sponsors have been able to go to an ID Card issuing facility and renew the ID Card of an incapacitated dependent over age 21. Dependents in this category are now entitled to an indefinite identification card. However, sponsor's will still be required to re-verify their dependent's eligibility every four years by resubmitting DD Form 137-5

(Dependency Statement Incapacitated Child over age 21) and DD Form 1172 (Application for Uniformed Services Identification Card DEERS Enrollment) to the Defense, Finance, and Accounting Service (DFAS), 8899 East 56th Street, ATTN: PMTEAC/Dependency, Indianapolis, Indiana, 46249. Sponsors may also fax this documentation to DFAS at 317-510-1084, or scan the documents and email them to dependency determination@dfas.mil. Bear in mind that emailing this information is unsecure unless you can encrypt the email using a method that will allow DFAS to unencrypt it.

Social Security Numbers Being Removed from ID Cards

SSNs will no longer be printed on cards and should not be relied on as a unique ID number. These changes are being made by the Department of Defense to protect the identity information of cardholders.

Changes to ID cards will occur when the cardholders' expired cards are renewed. The removal of SSNs will occur in three phases, all of which will occur upon ID card renewal:

Phase One:

Remove Dependent SSNs

To begin by end of calendar year 2008 Phase Two:

Remove printed SSNs from all cards* To begin by end of calendar year 2009 Phase Three:

Remove SSNs embedded in barcodes To begin during calendar year 2012

Retirees with an indefinite expiration date may start replacing their ID cards beginning in January 2010.

VSI/SSB Recoupment Changes

Recoupment of military retirees' Variable offered to active duty military members Separation Incentive (VSI), Special Separation Benefit (SSB) and separation payments by the Defense Finance and Accounting Service has been temporarily suspended pending a formal policy and legal review by the Department of De-

According to DFAS officials, the suspension of recoupment actions is being taken for military retirees in an active pay status effective for the May 2009 retired pay entitlements. Military retired pay for these members received on June 1, 2009, will not be reduced by any recoupment amounts.

VSI, SSB and certain other separation payments, such as severance pay, were

in an effort to reduce manpower in certain career fields, primarily during the 1990s. Those receiving these payments were also required to maintain an affiliation with the Ready Reserve of a military Reserve component. Provisions of these programs also included repayment should an individual remain with the Ready Reserve and earn status as a military retiree

The federal statutes governing these programs do not allow the Department of Defense or DFAS to alter repayment ratios or provide alternative repayment plans for these military retirees regardless of the financial hardships a retiree many be experiencing.

The policy and legal review will allow DoD and DFAS to determine what options, if any, may be available to allow DoD to meet its statutory responsibilities while providing relief to military retirees impacted by recoupment actions.

Letters to military retirees in a SSB, VSI and Separation Payment recoupment status have been mailed advising them of the suspension of recoupment payments. Upon completion of the review, these members will receive a letter prior to recommencement of repayment reductions to their retired pay advising them of the review conclusions.
