# **Retiree Appreciation Day 2010**

30 October 2010

Registration 0700/Opening Ceremony 0800

If you missed the Retiree Appreciation Day (RAD) last year, you missed a lot! Interest was so great that we ran out of room during the opening ceremony. But don't dismay. We have fixed that issue and will have plenty of room this year for Retirees and Family Members.

This year the event will be held on 30 October 2010 from 0700 to 1600 at the Passenger Processing Center (PPC) on Campbell Army Airfield, the same location as last year. The event in October is going to capitalize on all of the best things from past RADs, including breakfast, an exceptional Health Fair, and great Retiree related products from AAFES. To make the event as convenient as possible, all resources and organizations other than the ID Cards section will be located at the PPC under one roof (The ID Card office in Bldg 2577a will be open from 0800 to 1500).

At registration, you will be assisted by our very own Fort Campbell Retiree Council so you will be able to put a face with the name. After registration you will be able to roam through the activity hall, get your Flu shot at the Health Fair, or reserve yourself a seat for the opening ceremony.

The opening ceremony will begin with the Fort Campbell High School JROTC posting the colors and the Pledge of Allegiance. COL Dominic J. Caraccilo, Deputy Commander, 101st Airborne Division (AASLT) and Senior Commander, Fort Campbell, KY, will introduce the first of two exceptional Guest Speakers: Mr. Pradeep Gidwani, TRI-**CARE North Region Director** and LTG (Ret.) Roger Thompson Jr. of AUSA from Washington DC. Mr. Gidwani will brief on changes to TRICARE benefits as well as the state of recent contract negotiations and LTG Thompson will provide an in depth update on benefits and legislation.

Blanchfield Army Community Hospital will sponsor a health fair to provide preventive health, dietary, height/weight, blood pressure screenings and other valuable information related to your health. Pneumonia and Influenza vaccinations will be available for Retirees and Spouses, as well as Shingles vaccinations.

Fort Campbell is scheduled to provide numerous static displays manned by Soldiers recently returned from a tour of combat duty in Iraq and/or Afghanistan. The displays will feature weapons and equipment used by Soldiers in Operation Iraqi Freedom and Operation Enduring Freedom. Come by and see the changes to equipment you used when you served!

Brunch will be served in a Diing Facility (DFAC) from 1000-1300 for \$4.85. You will be

able to have breakfast, lunch, or a combination of both. Since we began offering a meal in the DFAC we have yet to receive a negative comment so come enjoy a great meal!

The door prize give-away will be held after lunch in Bay "D". AAFES again tops off the list of door prizes with a special gift. The door prize give-away will begin promptly at 1300 so don't be late! Remember, you must be present to win.

We will also make identification tags (dog tags) for any Retiree that wants a set. In order to reduce wait times, please fill out the form in the Pull-out and mail it to us so we can make a set in advance and have it ready for you. You may also have a set made while you wait.

And if these are not enough reasons to attend, there will be a special tour of Fort Campbell after the door prize give-aways including an Air Assault demonstration at Sabaulaski Air Assault School, a visit to Pratt Museum and an opportunity to familiarize with current small arms weapons at the Engagement Skills Trainer (EST). The EST is how today's Army trains with weapons and allows small units the opportunity to work on marksmanship skills and fire team coordination. The EST allows Soldiers to fire replica weapons at realistic target scenarios, all inside a building rather than on a range. The weapons are exactly like live fire weapons, have realistic recoil, and must be reloaded while firing.

## **Pharmacy Benefit Enhanced**

The TRICARE Management Activity is introducing significant new enhancements to beneficiaries as it combines its mail-order and retail pharmacy contracts into one new contract: TRICARE Pharmacy. The TRICARE Pharmacy Program provides outpatient prescription drugs to 9.5 million beneficiaries. TRI-CARE selected Express Scripts, Inc. to provide beneficiaries with mail-order, retail and specialty pharmacy services. Express Scripts currently handles millions of prescriptions each year through mail-order and retail pharmacies.

The improvements to the TRICARE Pharmacy program include the Specialty Medication Care Management program in the mail-order pharmacy; expansion of the Member Choice Center providing assistance to help beneficiaries switch their military treatment facility (MTF) prescriptions to mail-order; and one call center phone number: 1-877-363-1303.

The Specialty Medication Care Management program is for beneficiaries using the mail-order pharmacy for their specialty medications. It is structured to improve their health through continuous health evaluation, ongoing monitoring, assessment of education needs, and management of medication use.

The decision to combine mail-order and retail contracts resulted from obser-

vations that commercial insurance companies were doing the same thing with positive results. Combined call centers and claims processing will help control Depart- retail network pharmacies are rigorously ment of Defense pharmacy costs.

The TRICARE Pharmacy Program is designed to provide the medications beneficiaries need in a safe, convenient and cost-effective manner. The program has three objectives.

Provide a uniform, effective and efficient benefit. TRICARE provides beneficiaries with four high-quality pharmacy options: MTF pharmacies; the mail-order pharmacy; the TRICARE Retail Pharmacy network; and non-network retail pharma-

Encourage mail-order pharmacy use. The mail-order pharmacy is the least expensive option when not using a MTF pharmacy. Beneficiaries receive up to a 90 day supply of maintenance medications delivered directly to their home. The mailorder pharmacy now offers a program providing enhanced education to promote safe use of specialty medications requiring special handling and administration; frequent dose changes; and possible benefits from additional clinical monitoring. The Member Choice Center is available at 1-877-363-1433 to help beneficiaries switch prescriptions to the convenient, cost-effective mail-order pharmacy.

Promote patient safety. All prescriptions dispensed to beneficiaries through MTFs, the mail-order pharmacy and checked for accuracy and potential drug interactions by referencing new prescriptions against a beneficiary's prescription history.

The TRICARE Retail Pharmacy network includes all major national chains, more than 100 regional chains and more than 20,000 independent community pharmacies. Beneficiaries who are concerned about their current pharmacy's participation in the TRICARE retail network should ask their pharmacist if they are in the TRICARE network. Remember, the Retired military identification card is proof a Retiree qualifies for pharmacy benefits.

Also, if you are enrolled in Medicare Part D you will pay a premium, deductible, and co-pay for your medication. As the TRICARE pharmacy benefit is low or no cost to you, there is no reason to enroll in Medicare Part D unless you are below the U.S. poverty line and qualify for financial aid on your Part B premi-

## Preparing for the Inevitable

Although most people would rather not talk about it, the issue of what needs to be done upon a retiree's death is pertinent and should be addressed in order to provide valuable assistance to the survivor. Many times each month, the Retirement Services Office receives calls from grieving survivors who have no idea what to do or where to turn. The Casualty Assistance Center (CAC) and the Retirement Services Office are available to provide support and assistance to the survivor then and in the future.

In the event of a retiree death several actions must be taken as soon as possible. First, the survivor needs to contact the Defense Finance and Accounting Service (DFAS) at 1-800-269-5170 or 1-800-321-1080 and report the death. You will need the retiree's social security number and the date of death when you call. DFAS will then take steps to close out the pay account to prevent overpayment. If the retiree was enrolled in

the Survivor Benefit Plan (SBP) or Retired Serviceman's Family Protection Plan (RSFPP), they will take additional steps to initiate pay accounts for eligible survivors. DFAS will also send out paperwork that will need to be filled out and returned.

Next, call the Social Security Administration at 1-800-772-1213, the Defense Enrollment Eligibility Reporting System (DEERS) at 1-800-538-9552, and Department of Veterans Affairs (if the retiree was receiving disability compensation) at 1-800-827-1000. Lastly, contact the Ft. Campbell CAC at 270-798-4727/4729/2085. Additionally, the Army Casualty Website at https://www.hrc.army.mil/site/active/TAGD/CMAOC/cmaoc.htm, provides valuable information.

The CAC is the primary proponent on Fort for the Campbell for service-member deaths and are easier truly subject matter experts. They will provide time.

valuable assistance such as paperwork for pay and benefits, as well as one-on-one, personal assistance to help survivors through this difficult time. Keep in mind that paperwork for pay and benefits must be accompanied by a certificate of death.

Some retirees handle all of the family finances, keeping this information to themselves. This creates a huge problem upon their death, as the survivor has no idea of what and where bank accounts, life insurance policies, or investments are located. It is a good idea to organize all of this information so that the survivor can easily access these accounts.

Survivors handle this situation differently. Many grieve deeply and have a hard time dealing with the death and the myriad things that have to take place. Take the time to prepare for this traumatic event in order to make it easier for the survivor in this most difficult time.

# **Updating Retiree Records**

Previously, if a Retiree needed to make a the capabilities that were available at change to their records such as a name change due to divorce or remarriage, all they had to do was come by the Fort Campbell Retirement Services Office with the pertinent documentation and we were able to submit the requested change for them electronically. However, with the consolidation of the Human Resources Command (HRC) at Fort Knox, some of

HRC - St. Louis no longer exist. One of those is the records update process. Currently, if a Retiree needs to make a change to their records they must write a letter requesting the change and mail it to St. Louis. The Retiree will need to include their full name, social security number, mailing address, and telephone number along with the supporting docu-

mentation such as marriage license, divorce decree, or court order. The address to send the request is AHRC- Veterans Inquiry Branch, ATTN: PAV-V, One Reserve Way, St Louis, MO 63132-5200. Since this is a new process there is no way to tell how long it will take to make the requested change. We would appreciate any feedback from anyone who tries this as to how it worked for them.

## TRICARE and the New Health Care Law
