Retiree Appreciation Day 2011

If you watch television or listen to the radio, you would think that the only way to receive information about Retiree benefits is from the Internet. It's www this and .com that. But there is hope. Every year the Retirement Services Office and Fort Campbell host Retiree Appreciation Day (RAD). Mandated in AR 600-8-7, Retirement Services Program, the RAD is designed to provide information and updates on benefits, rights, and privileges of Retired service members.

This year the event will be held on 22 October 2011 from 0700 to 1600 at the Passenger Processing Center (PPC) on Campbell Army Airfield, the same location as last year. The event in October is going to capitalize on all of the best things from past RADs, including refreshments, an exceptional Health Fair, and great Retiree related products from AAFES. To make the event as convenient as possible, all resources and organizations other than the ID Cards section will be located at the PPC under one roof (The ID Card office in Bldg 2577A will be open from 0800 to 1500).

At registration, you will be assisted by our very own Fort Campbell Retiree Council so you will be able to put a face with the name. After registration you will be able to roam

through the activity hall, get your Flu shot at the Health Fair, or reserve yourself a seat for the opening ceremony.

The opening ceremony will begin with the Fort Campbell High School JROTC posting the colors and then we will Pledge Allegiance. A member of the Fort Campbell Command Team will provide opening remarks and introduce the Guest Speaker, Mrs. Kim McMillan, Mayor of Clarksville, Tennessee.

Blanchfield Army Community Hospital will sponsor a health fair to provide preventive health, dietary, height/weight, blood pressure screenings and other valuable information related to your health. Pneumonia and Influenza vaccinations will be available for Retirees and Spouses, as well as Shingles vaccinations.

Fort Campbell is scheduled to provide numerous static displays manned by Soldiers recently returned from a tour of combat duty in Iraq and/or Afghanistan. The displays will feature weapons and equipment used by Soldiers in Operations Iraqi Freedom and Enduring Freedom. Come by and check it out!

Brunch will be served in a Dining Facility (DFAC) from 1000-1300 for \$4.85. You will be able to have breakfast, lunch, or a combination of both, so come enjoy a great meal!

We will also make identification tags (dog tags) for any Re-

tiree that wants a set. In order to reduce wait times, please fill out the form in the Pull-out and mail it to us so we can make a set in advance and have it ready for you. You may also have a set made while you wait.

And if these are not enough reasons to attend, there will be a special tour of Fort Campbell after the door prize give-aways including an Air Assault demonstration at Sabaulaski Air Assault School, a visit to Pratt Museum and an opportunity to familiarize with current small arms weapons at the Engagement Skills Trainer to fire replica weapons at realistic target scenarios, all inside a building rather than on a range.

Of course we will have all of the great supporting organizations for you to talk to at length including Retired Pay from the Defense Finance and Accounting Service, Department of Veterans Affairs, Veterans of Foreign Wars, the Fort Campbell Historical Society and more.

For those that would like the opportunity to purchase Retiree related items like hats, glasses, bumper stickers, etc., AAFES will be selling a large selection of these goods on site. Debt vs. Department of Defense

Budget cuts and austerity measures have become common nature as of late in the United States and worldwide. Due to larger than ever budget deficits and debt measured in the tens of trillions of dollars, the Federal government is looking hard at the Department of Defense (DoD) as a way to shave billions of these numbers. In the past, Department of Defense has been purposely overlooked in situations such as this, but no longer. As the Wars in Iraq and Afghanistan draw down, what many thought would be a small “peace dividend” may now become what many fear; the hollowing out of our Armed Forces and drastically reduced benefits for Retirees.

Earlier this year the President asked for a \$400 billion (that’s four hundred thousand, million dollars) reduction of DoD spending. It now looks like that number will be at least doubled or more. And with these cuts there is now a full court press on the current retirement plan. Calling the current plan “unfair, unaffordable, and inflexible,” the Defense Business Board recommended not so subtle changes to military retirements. Although advocates of the current plan remind the President, Congress, and anyone else who will listen

that Retiree benefits are earned through a lifetime of service and sacrifice the likes that civilians not associated with the military likely have never seen or heard of, bean counters are still looking at changing the current plan and more importantly, looking at changing Retiree benefits as well. Increases to health care benefits are coming. It is not a question of if anymore, it is now simply a question of when. And if DoD is asked to trim another \$400 billion, look out! One of the easiest targets nowadays, despite the general feelings of support for the military, are military benefits, especially Retiree benefits. For some reason, working age Retirees are now looked at as though they are gaming the system. There is no telling how many times articles have been written or comments made about working age Retirees who are drawing military pensions *and* getting paid for working. It is almost as if these Retirees are being compared to welfare cheats.

The problem lies, like most any problem, with lack of knowledge. Civilians simply do not know what a career in the military is really like. Of course they see what Hollywood portrays in the movies, but that is never even close to the real life of a ca-

reerist. Civilians cannot fathom getting up at 0400 to go to work, get the Soldiers up for first formation, and then doing physical training. By the time we ate breakfast we had been working for three hours already. Then we would work all day and if we were lucky, would be home around 1800 or 1900 for a cold dinner. This daily life plus deployments around the world in peacetime and in war are the service and sacrifice that are paid in kind for the benefits we receive when we retire.

So what can you do about it? Contact your elected representatives in the House of Representatives and Senate. Let your relatives and friends in other states know what is happening and have them do the same. Join a Veterans Service Organization whose mission is to lobby on behalf of Veterans and Retirees. But most importantly, do something. The squeaky wheel gets the grease and if we don’t make our voices heard in a big way, the only thing we are going to get is the shaft.

Need to Update Personal Information?

If you need to make a change to your records such as a name change due to divorce or remarriage, all you have to do is come by the Fort Campbell Retirement Services Office with the pertinent documentation and we are now able to submit the requested change for you electronically. With the consolidation of the Human Resources Command (HRC) at Fort Knox complete, the electronic process is available again.

A Retiree may also make a change to their records by email or writing a letter requesting the change and mail it to Human Resources Command. The email address is veterans@conus.army.mil. The Retiree will need to include their full name, social security number, mailing address, and telephone number along with the supporting documentation such as marriage license, divorce decree, or court order. The address to send a hard copy request is HRC, ATTN:

AHRC-PDR-RCR, 1600 Spearhead Division Avenue, Dept. 420, Fort Knox, KY 40122-5402.

Unfortunately, there is no way to tell how long it will take to make the requested change.

We would appreciate any feedback from anyone who tries this as to how it worked for them.

Remember to keep your mailing address updated with DFAS. You may change your address using MyPay, by calling the RS0 at 270-798-5280/3310, or by contacting DFAS at 1-800-321-1080.

Although most people would rather not talk about it, the issue of what needs to be done upon a retiree's death is pertinent and should be addressed in order to provide valuable assistance to the survivor. Many times each month, the Retirement Services Office receives calls from grieving survivors who have no idea what to do or where to turn. The Casualty Assistance Center (CAC) and the Retirement Services Office are available to provide support and assistance to the survivor then and in the future.

In the event of a retiree death several actions must be taken as soon as possible. First, the survivor needs to contact the Defense Finance and Accounting Service (DFAS) at 1-800-269-5170 or 1-800-321-1080 and report the death. You will need the retiree's social security number and the date of death when you call. DFAS will then take steps to close out the pay account to prevent overpayment. If the retiree was enrolled in the

Survivor Benefit Plan (SBP) or Retired Serviceman's Family Protection Plan (RSFPP), they will take additional steps to initiate pay accounts for eligible survivors. DFAS will also send out paperwork that will need to be filled out and returned.

Next, call the Social Security Administration at 1-800-772-1213, the Defense Enrollment Eligibility Reporting System (DEERS) at 1-800-538-9552, and Department of Veterans Affairs (if the retiree was receiving disability compensation) at 1-800-827-1000. Lastly, contact the Ft. Campbell CAC at 270-798-4727/4729/2085. Additionally, the Army Casualty Website at <https://www.hrc.army.mil/site/active/TAGD/CMAOC/cmaoc.htm>, provides valuable information.

The CAC is the primary proponent on Fort Campbell for service-member deaths and are truly subject matter experts. They will provide valuable assistance such as

paperwork for pay and benefits, as well as one-on-one, personal assistance to help survivors through this difficult time. Keep in mind that paperwork for pay and benefits must be accompanied by a certificate of death.

Some retirees handle all of the family finances, keeping this information to themselves. This creates a huge problem upon their death, as the survivor has no idea of what and where bank accounts, life insurance policies, or investments are located. It is a good idea to organize all of this information so that the survivor can easily access these accounts.

Survivors handle this situation differently. Many grieve deeply and have a hard time dealing with the death and the myriad things that have to take place. Take the time to prepare for this traumatic event in order to make it easier for the survivor in this most difficult time.

The TRICARE Young Adult (TYA) program is a premium-based health care plan available for purchase by *qualified dependents*. TYA offers TRICARE Standard coverage worldwide, and TRICARE Prime coverage will be available for purchase at a later date. TYA includes medical and pharmacy benefits, but excludes dental coverage.

Who Is Eligible?

If you are an adult-age dependent, you may purchase TYA Standard coverage based on the eligibility established by your uniformed service sponsor.

Note: Special eligibility conditions may exist.

You may purchase TYA coverage if you are all of the following:

- A dependent of an eligible uniformed service sponsor
- Unmarried
- At least age 21 (or age 23 if enrolled in a full-time course of study at an approved institution of higher learning and if the sponsor provides at least 50 percent of the financial support), but have not yet reached age 26
- Not eligible to enroll in an employer-sponsored health plan as defined in TYA regulations
- Not otherwise eligible for TRICARE program coverage.

Purchasing TRICARE Young Adult

TYA offers open enrollment, so if you qualify, you may purchase coverage at any time. The TRICARE Young Adult Application is available at

www.tricare.mil/tya. When applying, you must verify that you are not married and not eligible to enroll in an employer-

sponsored health plan. **Note:** If you are not already in the Defense Enrollment Eligibility Reporting System (DEERS), your sponsor must add you to the system before starting the application process. For information on adding family members to DEERS, visit

www.tricare.mil/deers. Once you complete and sign the application, take it, along with your initial premium payment, to a TRICARE Service Center, or mail or fax it to your regional contractor.

Your completed application must include the first three months of premium payments, paid by personal check, cashier's check, money order, or credit/debit card. After the initial three-month payment, premiums must be paid in advance by monthly automated payment.

Enrollment in TRICARE Young Adult

After enrolling in TYA, you and your sponsor will need to visit a uniformed services identification (ID) card issuing facility to obtain an ID card for you. You must bring two forms of ID—one must be an unexpired government-issued ID card with a picture. After your enrollment application is processed and payment is received, TRICARE Standard coverage will begin the first day of the following month.

Retroactive Coverage

You may purchase TRICARE Standard coverage retroactively back to January 1, 2011, or back to the date you became eligible for coverage. All premiums must be paid back to that date in order for care to be

reimbursed. Beneficiaries who may want to purchase retroactive coverage should keep receipts for care received to get reimbursed for covered services. The opportunity to purchase retroactive coverage ends on September 30, 2011.

Note: Retroactive coverage is limited to the TRICARE Standard benefit only.

TRICARE Young Adult Standard Costs and Fees

The 2011 monthly premium for TYA Standard coverage is \$186. TYA premiums are adjusted annually, effective January 1. Ongoing premiums must be paid in advance by automated payment. Premiums are not credited to deductibles or catastrophic caps.

TYA Standard has the same cost-shares as TRICARE Standard and TRICARE Extra. TYA cost-shares contribute to individual and family deductibles and to your family's catastrophic cap. The annual deductible varies based on your sponsor's category.

Many of you have probably heard by now that TRICARE Prime enrollment fees may increase in the near future (there are no proposed increases to TRICARE Standard or TRICARE for Life coverage). While the legislation has not yet passed it is looking more and more like it will happen. The proposed increases will be \$2.50 a month for individuals (from \$230 to \$260 annually) and \$5 a month for families (from \$460 to \$520 annually). The good news (if you can call any increase good news) is that future TRICARE

fee increases will be tied to the annual Cost of Living Allowance (COLA) increase in military retired pay, not to the National Health Expenditure index, as some have proposed and which would mean higher fee increases. For example, if the COLA increase is 2.5%, the increase to TRICARE Prime fees would be 2.5% of \$260/\$520 annually. Retirees would not “lose” their entire COLA increase, but more would go to TRICARE fees.

Prescription medications may also see a slight increase by \$2 or \$3 while eliminating copayments for generic drugs ordered through the mail-order pharmacy program. Of course, you can always receive your prescription medication on post for free. Any increase to both TRICARE Prime and prescription medications could be effective as early as October 1, 2011. We will keep you posted on any changes as they happen. Check our website once in a while at www.campbell.army.mil/retirement.

TRICARE Retired Reserve Plan

TRICARE Retired Reserve (TRR) is a premium-based, worldwide health plan that qualified retired Reserve members and survivors may purchase. It offers comprehensive health coverage from any TRICARE-authorized provider, network or non-network. Referrals are not needed for any type of care but some services may require prior authorization.

Monthly Premiums

TRR Member-Only coverage: \$408.01 per month
TRR Member-and-Family coverage: \$1,020.05 per month
Premium amounts may be adjusted an-

nually, effective January 1 each year, in accordance with applicable legislation.
Note: The law requires members to pay the full cost of coverage under TRR with no government subsidy.

To Qualify

Retired Reserve members may qualify if they are:
Members of the retired Reserve of a Reserve Component who are qualified for non-regular retirement under 10 U.S.C., Chapter 1223
Under age 60
Not eligible for, or enrolled in, the Federal Employees Health Benefits (FEHB) program

Survivors of retired Reserve members may qualify if all of the following applies:

The sponsor was covered by TRR on the date of his or her death.
They are immediate family members of the deceased sponsor (*spouses cannot have remarried*).
TRR coverage would begin before the date the deceased sponsor would have turned 60 years old.

Note: Survivor coverage is not affected by FEHB eligibility
