SUBJECT: U.S. Army Security Assistance Command (USASAC) Policy Memorandum 207.6 –
Web Site Policy

1. The USASAC Web Site (www.usasac.army.mil) has been reorganized, redesigned and reviewed to comply with Department of Defense (DoD) Web Site policy and Army Regulation (AR) 25-1, Army Knowledge Management and Information Technology, 4 December 2008; and AR 360-1, The Army Public Affairs Program, 15 September 2000.

a. For security purposes, this reorganization determines what information is intended for the public audience versus what information is intended for the internal audience.

b. All information that was on the previous USASAC Web Site is still available, but it has been assigned to the appropriate site.

2. In accordance with DoD Web Site policy and Army Web Site regulations AR 25-1 and AR 360-1, the USASAC Public Affairs Office (PAO) has oversight of the public Web Site, www.usasac.army.mil. Any information on the site will be cleared through the USASAC PAO. The USASAC Chief Information Officer (CIO) has oversight of the internal site, intranet.usasac.army.mil.

3. The purpose of the USASAC public Web Site is to provide information to the general public about USASAC activities, programs, missions, and functions. All other information will be moved to the internal site. Examples of public sites include:

- a. Public affairs news and information
- b. Leadership biographies
- c. Freedom of Information Act
- d. Country listings
- e. Business opportunities

4. The purpose of the USASAC internal site is to provide information to the USASAC workforce, DoD personnel, and defense contractors. The internal site will provide a liberal environment for all staff elements to share their information. Examples of such sites include:

- a. Training information
- b. Employee benefits
- c. Union information
- d. All FOUO materials

Army Knowledge Online registration information is available online at www.us.army.mil and is open to Soldiers, civilians, contractors, retirees, and family members.
