# **Chesapeake Bay Small Watershed Grants**

## **Helping Local Partners Restore the Chesapeake**

#### The Challenge

The Chesapeake Executive Council recognized that retaining and expanding watershed forests is critical to our success in restoring the Chesapeake Bay. Key partners in this work are local governments and organizations throughout this 64,000 square mile watershed. The Northeastern Area (NA) and other partners in the Chesapeake Bay Program have joined with the National Fish and Wildlife Foundation (NFWF) to provide Small Watershed Grants to get technical and financial assistance to our local partners.

#### **The Solution**

The purpose of the Chesapeake Bay Small Watershed Grants program is to support protection and restoration actions that directly contribute to restoring healthy waters, habitat and living resources of the Chesapeake Bay ecosystem, while building citizen-based stewardship. This is also a vehicle for integrating multiple sources of federal funds. It is designed to encourage the development and sharing of innovative ideas for restoration and conservation among the organizations and local governments. The following awards were given in 2007:

## **Resulting Benefits**

Every dollar of Forest Service funding was matched with more than \$3 in partner contributions. Since 2001, approximately \$14 million worth of projects have been awarded to our local partners with approximately \$2.4 million in Forest Service investment. NA works with a team of state forestry partners, and other federal agencies to select the best projects.

An evaluation of the Chesapeake Small Watershed Grants program was conducted in 2006. The purpose was to improve the long-term environmental effectiveness of the dollars invested in this program.
