Headquarters ANG Title 10 2-4 years Statutory Tour at NGB/A2 (Joint Base Andrews, MD). Must be Air Force Specialty Code (AFSC) 14N3/4. Must have or be able to obtain TS Clearance. Duties and Responsibilities: Responsible for all ANG functional area management issues pertaining to AF Distributed Common Ground System (AF DCGS), targeting/geospatial intel (GEOINT), signals intelligence (SIGINT)/cyber ISR, and all-source intelligence analysis units. Incumbent should possess significant AF ISR operations experience in AF DCGS, targeting/GEOINT, SIGINT/Cyber ISR, or allsource intelligence analysis. Previous supervisory experience desired. Knowledge functions/organizational structure of the NGB/ANGRC staff, AF, MAJCOMs and NAFs, and the States/Territories is highly desired. Familiarity with staff procedures and actions including manpower, and planning, programming, budgeting, and execution (PPBE) processes is desired. Should possess good technical writing and briefing skills. Incumbent will be employed full time in a standard AF/ANGRC duty day work schedule; however, may be required to augment 24/7 National Guard Communications Center (NGCC) operations during real-world and exercise situations. Incumbent will interface with the NGB/ANGRC staff, HAF, the MAJCOMs and NAFs, and the States/Territories to synchronize and coordinate current/future ANG ground-based ISR organize, train and equip (OT&E) issues. routinely communicate with ANG ISR Wing, Group & Squadron Commanders and their staffs to conduct OT&E responsibilities and to solicit field inputs to answer ANG, AF, and DoD inquiries. Primary POC for ANG ground-based ISR operations and future planning, to include emerging ISR missions. As such, incumbent's responsibilities range from participating in DoD/NGB/AF/MAJCOM senior-level ISR planning forums to tracking all headquarters staff-related organize, train and equip issues for each ANG ground-based ISR field unit. Responsible for oversight and guidance of the ANG's DCGS, targeting/GEOINT, SIGINT/cyber ISR and all-source intelligence analysis Functional Area Managers (FAMs), and ensuring ANG equities are included in current/future AF plans for these weapon systems/intelligence disciplines.

Mandatory criteria as indicated in the MVA must be documented on the members report on individual personnel (RIP). If it is not indicated on the RIP, it is incumbent upon the applicant to ensure that the appropriate source documentation is provided with the application.

Must meet the above stated grade/rank requirement by closeout date of advertisement.

Member must have a Secret Clearance or an open investigation to apply for statutory tour positions.

Officers applying for a statutory tour position must have a minimum of a Bachelors degree prior to applying.

Any MVA to an overseas location will require additional screening for the selectee and family prior to orders publication.

Enlisted applicants who are higher grade than the highest grade for the advertisement must provide a statement of understanding with the application stating he/she is willing to be voluntarily demoted if selected for this position, IAW ANGI 36-2503, Paragraph 3.8.

Members in a Special Duty Career Field (SDI)/Reporting Identifiers (RI) must submit a conditional release letter from your Functional Area Manager (FAM) stating you have fulfilled all obligations and will be released if selected for the position you are applying for. If selected for an MVA outside of the SDI (8XXX) or RDI (9XXX) you must have a fully qualified AFSC prior to accession onto Stat Tour AFSC(1XXX-7XXX)

Applications will be reviewed for qualification/disqualification only starting at 72 hours prior to closeout date. For example; an MVA closing out on the 10th of the month would be reviewed for qualified or disqualified only starting on the 7th of the month.
