Headquarters ANG Title 10 2-4 years Statutory Tour at **NGB/A3 (MacDill AFB, FL)**. Must be Air Force Specialty Code (AFSC) **11M3/4 or 11F3/4**. **Must have or be able to obtain TS SCI clearance. API 8.** Duties and Responsibilities: Incumbent should have knowledge/experience and understanding of CJCS focal point messaging system required in support of SOF missions, organizations, command and control and communications (C3) functions. It is highly desired the incumbent have experience with special operations forces, missions, C3 functions and previous (GK) experience as an aircrew or staff member. Incumbent functions as the single point of contact for all GK missions and related issues within the United States Special Operations Command, as a member of the USSOCOM-J3 staff. Incumbent functions as Title 10 program liaison to DoD Components, the Joint Staff, Department of State, and other government agencies on GK issues. Incumbent is responsible to coordinate on the AFSOC development and submission of GK's programmatic actions for USSOCOM. Reviews mission requirements to insure sufficient resources are programmed for the GK program. Develops and evaluates proposed policy and guidance over the GK program under USSOCOM responsibility. Develops in conjunction with the Air National Guard and AFSOC, policies relating to operations, training, and maintenance of combat readiness, base support, logistics and mobility requirements for the classified GK mission. Responsible for the coordination of all classified and unclassified missions assigned to GK. Incumbent is desired to have mid-level management skills. Should possess a knowledge and experience which would demonstrate an ability to plan and execute staff efforts toward the successful accomplishment of present and future requirements. Some expertise is required on ANG policies and procedures for war planning, force structures programs, budget development, operational programs, personnel management and associated programs. Prepares staffing actions for submission within USSOCOM, the Director, Air National Guard, HQ AFSOC, and other U.S. Government agencies. Incumbent maintains a continuous liaison among USSOCOM, AFSOC, and NGB concerning policies and procedures affecting the GK. Incumbent may maintain flight currency. May fly with ANG Special Operations Force units to conduct unit visits, to evaluate unit capabilities, and the effectiveness of the program's policies affecting mission readiness. Incumbent performs other duties as assigned within USSOCOM- J31.requirements. Prepares staffing actions for submission to USSOCOM/-J3, and/or CDR USSOCOM, as well as NGB/A3 and Director, ANG.

Mandatory criteria as indicated in the MVA must be documented on the members report on individual personnel (RIP). If it is not indicated on the RIP, it is incumbent upon the applicant to ensure that the appropriate source documentation is provided with the application.

Must meet the above stated grade/rank requirement by closeout date of advertisement.

Member must have a Secret Clearance or an open investigation to apply for statutory tour positions.

Officers applying for a statutory tour position must have a minimum of a Bachelors degree prior to applying.

Any MVA to an overseas location will require additional screening for the selectee and family prior to orders publication.

Applications will be reviewed for qualification/disqualification only starting at 72 hours prior to closeout date. For example; an MVA closing out on the 10th of the month would be reviewed for qualified or disqualified only starting on the 7th of the month.

Application for this MVA signifies agreement to the following statement, "I certify that, to the best of my knowledge and belief, all of the information in and attached to this application is true, correct, complete and made in good faith. I understand that false or fraudulent information on or attached to this application may be grounds for rejection or for release from statutory tour after I begin work, and may be punishable by fine or imprisonment.
