Responsibilities: Serves as the Deputy Director, Program Integration, covering legislative, information management, and budget programs; and principal advisor to the Deputy Assistant Secretary of Defense (DASD) for Resources on National Guard and Reserve Matters. Provides analysis, support, input, synopsis, and briefings to the ASD/RA for legislative and Congressional actions and inquiries affecting the Reserve components (RCs). Prepares and accompanies the ASD/RA and DASDs to, and provides back up for, all hearings before Congressional committees, ensuring Posture Statements, transcripts and questions for the record (QFRs) are completed accurately and on time. Creates a "side-by-side" comparison and synopsis of the House and Senate Authorization and Appropriation bills. Develops appeals to House, Senate or conference as appropriate. Analyzes the RC budget submissions as required for presentation to the DASD. Provides research, analysis, input, and coordination to the POM/PBD process across the RCs at the OSD level. Authors, researches, contributes and edits several high level official publications throughout the cycle as required. Position is also appointed to a position on the OSD/RA COOP Team.

Mandatory criteria as indicated in the MVA must be documented on the members report on individual personnel (RIP). If it is not indicated on the RIP, it is incumbent upon the applicant to ensure that the appropriate source documentation is provided with the application.

Must meet the above stated grade/rank requirement by closeout date of advertisement.

Member must have a Secret Clearance or an open investigation to apply for statutory tour positions.

Officers applying for a statutory tour position must have a minimum of a Bachelors degree prior to applying.

Any MVA to an overseas location will require additional screening for the selectee and family prior to orders publication.

Applications will be reviewed for qualification/disqualification only starting at 72 hours prior to closeout date. For example; an MVA closing out on the 10th of the month would be reviewed for qualified or disqualified only starting on the 7th of the month.
