Headquarters ANG Title 10 2-4 years Statutory Tour at **NGB/A1 (Joint Base Andrews, MD)**. Must be Air Force Specialty Code (AFSC) **ANY**. Duties and Responsibilities: **Strong personnel background is highly desired**. Responsible for the programming, budgeting, allocation, execution and analytical duties involving the Air National Guard training funds and the formal school workday program to include ground, flying conversions, recruit training, and the Air National Guard Training and Education Center. Works directly with HQ USAF staff, NGB functional program element monitors, ANG staff, and field base training and education managers, base workday control officers/comptrollers. Program Element Monitor (PEM) maintaining three ANG training programs (flying, initial skill, upgrade, professional military education and recruit training) totaling over 250 million dollars, to include military personnel funds. Participates in the DoD Biennial Planning, Programming, Budgeting and Execution System (PPBES) process, and the Future Years Development Plan (FYDP). Develops and implements the ANG portion of the Air Force Program Objective Memorandum (POM) submission to the AF Personnel and Training Panel. Develops, evaluates and administers projections for balanced phasing, modernization, realignment, future alternatives and feasibility. Reviews all ANG mission requirements to ensure sufficient resources are programmed to ensure mission accomplishment. Develops options and alternative strategies to balance fiscal constraints and mission requirements. Presents the ANG Program to DoD and Air Force staffs. Prepares staffing actions for submission to other ANGRC and NGB offices, major commands, HQ USAF, DoD Agencies and states and Congress.

Mandatory criteria as indicated in the MVA must be documented on the members report on individual personnel (RIP). If it is not indicated on the RIP, it is incumbent upon the applicant to ensure that the appropriate source documentation is provided with the application.

Must meet the above stated grade/rank requirement by closeout date of advertisement.

Member must have a Secret Clearance or an open investigation to apply for statutory tour positions.

Officers applying for a statutory tour position must have a minimum of a Bachelors degree prior to applying.

Any MVA to an overseas location will require additional screening for the selectee and family prior to orders publication.

Enlisted applicants who are higher grade than the highest grade for the advertisement must provide a statement of understanding with the application stating he/she is willing to be voluntarily demoted if selected for this position, IAW ANGI 36-2503, Paragraph 3.8.

Members in a Special Duty Career Field (SDI)/Reporting Identifiers (RI) must submit a conditional release letter from your Functional Area Manager (FAM) stating you have fulfilled all obligations and will be released if selected for the position you are applying for. If selected for an MVA outside of the SDI (8XXX) or RDI (9XXX) you must have a fully qualified AFSC prior to accession onto Stat Tour AFSC(1XXX-7XXX)

Applications will be reviewed for qualification/disqualification only starting at 72 hours prior to closeout date. For example; an MVA closing out on the 10th of the month would be reviewed for qualified or disqualified only starting on the 7th of the month.

Application for this MVA signifies agreement to the following statement, "I certify that, to the best of my knowledge and belief, all of the information in and attached to this application is true, correct, complete and made in good faith. I understand that false or fraudulent information on or attached to this application may be grounds for rejection or for release from statutory tour after I begin work, and may be punishable by fine or imprisonment.
