SUPPLEMENTARY INFORMATION: The Commission instituted this patent-based section 337 investigation on January 24, 2002, based on a complaint filed by the Nikon Corporation of Tokyo, Japan, and Nikon Precision Inc. and Nikon Research Corporation of America of Belmont, California (collectively "Nikon"). The respondents named in the investigation are ASM Lithography Holding N.V. and ASM Lithography B.V. of the Netherlands and ASM Lithography of Tempe, Arizona (collectively, "ASM"). The complaint alleges that ASM has violated section 337 of the Tariff Act of 1930 by importing into the United States, selling for importation, and/or selling within the United States after importation certain microlithographic machines and components thereof by reason of infringement of certain claims of U.S. Letters Patents Nos. 5,638,211, 6,233,041, 5,473,410, 6,271,640, 6,008,500, 6,255,796, and 6,323,935.

On May 16, 2002, complainant Nikon moved pursuant to rule 210.14(b) to amend the complaint and notice of investigation to include certain corrections and additions to confidential Exhibit 16 concerning foreign counterpart patents and patent applications, and to amend the complaint and notice of investigation to reflect the fact that respondent ASM Lithography B.V. has changed its name to ASML Netherlands B.V. There was no opposition to the motion.

On June 14, 2002, the ALJ issued an ID (Order No. 10) granting complainants' unopposed motion to amend the complaint and notice of investigation. No petitions for review of the ID were filed.

The authority for the Commission's action is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337) and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
