Technical comments:³

Editorial changes were made to the proposed chemical description given in the bill. Further, the Commission notes that the article description in HTS subheading 9902.32.46, which effectively is being renewed, included the Color Index name for the product (i.e., Reactive yellow 138:1) and recommends that this reference be retained in the new article description to facilitate the administration of this provision by Customs.

³ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
