
The subject chemical is a light stabilizer used in plastic articles to retard degradation cracking caused by ultraviolet light.

This chemical is imported from India.

3 **SECTION 1. SUSPENSION OF DUTY ON BIS (2,2,6,6,-**
4 **TETRAMETHYL-4-PIPERIDYL) SEBACEATE.**

5 (a) IN GENERAL.—Subchapter II of chapter 99 of
6 the Harmonized Tariff Schedule of the United States is
7 amended by inserting in numerical sequence the following:
