The subject product, 1,2-hexanediol, is an organic chemical used in cosmetics, coatings, glue, adhesives, and inks. It is imported mainly from Germany.



3 **SECTION 1. SUSPENSION OF DUTY ON 1,2 PENTANEDIOL.**

4 (a) IN GENERAL.—Subchapter II of chapter 99 of  
5 the Harmonized Tariff Schedule of the United States is  
6 amended by inserting in numerical sequence the following:
