#### ABSTRACT:

The following tables present official and unofficial data on U.S. overseas loan and grant obligations to Ethiopia, 1952 – 2011. Official statistics for FY 1952 through FY2009 were obtained from the *U.S. Overseas Loans and Grants - Obligations and Loan Authorizations* web site (also known as "the Green Book"). Unofficial statistics for FY 2010 and FY 2011 were obtained from USAID/Ethiopia. They have been converted from current U.S. dollars into 2009 constant U.S. dollars by the USAID Economic Analysis and Data Services (EADS) group.
