LIPINSKI FIGHTS TO STRENGTHEN MEDICARE AND LOWER COSTS



Congressman Lipinski visits Christ Hospital, touring the new facility that provides medical care for many seniors in the 3rd District.

In August, Congressman Lipinski worked to pass the Children's Health and Medicare Protection (CHAMP) Act. In addition to helping provide health insurance for more children, this bill will strengthen Medicare and help seniors by:

- Cutting your costs by eliminating co-payments and deductibles for preventive health care
- Ensuring continued access to doctors of your choice by stopping a 10% cut in Medicare payments
- Expanding programs to ensure Medicare remains affordable

LIPINSKI WORKS TO LOWER MEDICARE DRUG PRICES



Congressman Lipinski has fought for lowering prescription drug prices for seniors since he entered Congress. Earlier this year, he helped introduce and pass legislation to require the government to negotiate for lower drug prices for Medicare beneficiaries. The Medicare Prescription Drug Negotiation Act of 2007 changes current law to require the Secretary of Health and Human Services to negotiate with drug companies for lower prices.

LIPINSKI CONTINUES EFFORT TO STRENGTHEN SOCIAL SECURITY AND PROTECT BENEFITS FOR SENIORS

Social Security has allowed the United States to enjoy one of the lowest poverty rates for seniors. Congressman Lipinski (shown discussing Social Security issues with district seniors) believes that Social Security must be strengthened and continues to oppose privatization of parts of Social Security because it would put future benefits at risk for seniors. Although the President's plan was defeated last year, it is critical that we continue to work to make sure Social Security benefits are protected.
