

# Partnership to Fight HIV/AIDS in Cote d'Ivoire

The United States is supporting Cote d'Ivoire as it takes the leadership role in its fight against HIV/AIDS.

### **Saving Lives: PEPFAR Program Results**

Progress achieved in Cote d'Ivoire through direct PEPFAR support during fiscal year (FY) 20111:

- •64,800 individuals receiving antiretroviral treatment
- •231,500 HIV-positive individuals received care and support (including TB/HIV)
- •726,800 individuals received counseling and testing
- •101,600 orphans and vulnerable children (OVCs) received support
- •9,000 HIV-positive pregnant women received antiretroviral prophylaxis for PMTCT
- •332,000 pregnant women with known HIV status received services
- •2,788 estimated infant HIV infections averted



#### HIV/AIDS in Cote d'Ivoire

- •Adult (15–49) HIV prevalence, 2009: **3.4**%<sup>3</sup>
- •Estimated adults and children (ages 0-49) living with HIV, 2009: **450,000**<sup>3</sup>
- •HIV-related deaths, 2009: 36,000<sup>3</sup>
- •Orphans due to AIDS, 2009: 444,0003
- •Estimated number of people needing antiretroviral therapy based on WHO 2010 guidelines, 2009: **260,000**<sup>4</sup>
- •Estimated percentage of pregnant women living with HIV who received antiretrovirals for preventing mother-to-child transmission, 2009: **54**%<sup>4</sup>
