### History of Ballyhoo fishing in the SPAS

- In the first FKNMS management plan, an exemption to in four Upper Keys SPA's to allow cast netting (by permit) for ballyhoo. (SPA's included were Conch Reef, Hen and Chickens, Davis Reef, and Alligator Reef)
- Commercial ballyhoo fishermen were also allowed to drift into SPA's as they pulled in their nets, but were not allowed to set the nets in SPA's.

#### Hair Hooking Exemption History

- Islamorada Charterboat Association approached the SAC in early 2000's with a request to consider allowing hairhooking for ballyhoo in four different Upper Keys SPA's
- A ballyhoo working group was formed, and recommendations were presented to the full SAC in 2003/2004
- SAC modified the recommendations and suggested to the FKNMS superintendant that a trial, permit system be developed to allow hairhooking for ballyhoo in 3 Upper Keys SPA's

#### SPA Hairhooking Rules

- Permitting system put in place beginning 2004
- FKNMS permit required to fish in the SPA's
- FKNMS Approves flag must be flown during hair hooking
- No hairhooking after 10:00 am
- Annual permits indicating number of fishing events, location of effort, and any bi-catch
- Only allowed in three SPA's (Conch, Davis, Alligator)
- Seasonal only (October 15 to April 15)
