The United States Institute of Peace is an independent, nonpartisan, federal institution created and funded by Congress to strengthen the nation's capacity to promote the peaceful resolution of international conflict. Established in 1984, the Institute has its origins in the tradition of American statesmanship, which seeks to limit international violence and to achieve a just peace based on freedom and human dignity. The Institute meets its congressional mandate to expand available knowledge about ways to achieve a more peaceful world through an array of programs including grantmaking, a three-tiered fellowship program, research and studies projects, development of library resources, and a variety of citizen education activities.
