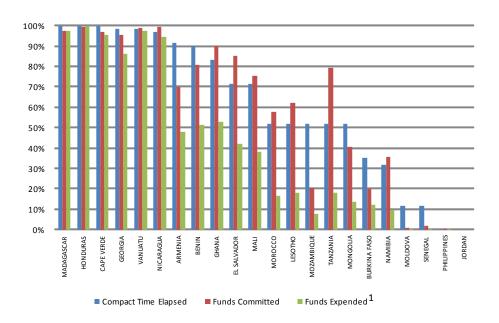

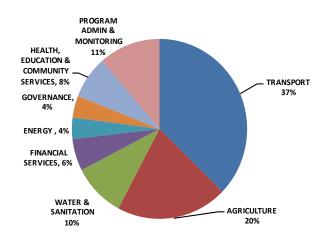

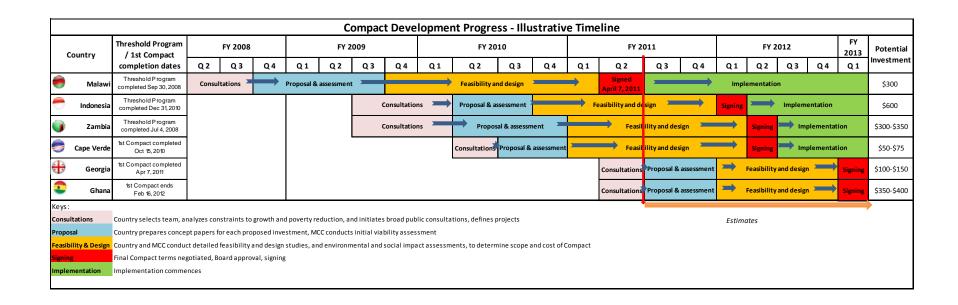

The Armenia Compact includes strategic investments designed to reduce rural poverty through a sustainable increase in the economic performance of Armenia's agricultural sector by refurbishing and improving major sections of the country's irrigation system. The program is also training 45,000 farmers in improved agriculture practices, delivering technical assistance to water supply institutions and providing US\$8.5 million in credit to farmers and small agribusinesses in support of the program objectives.

As result of the June 2009 meeting of MCC's Board of Directors, MCC did not resume funding for the Compact's Rural Road Rehabilitation Project (RRRP).

Compact Projects

Irrigated Agriculture Project

This project aims to increase agricultural productivity by extending and improving the quality of irrigation system through the rehabilitation and construction of infrastructure, including main canals, gravity schemes, pumping stations, and tertiary canals, and by strengthening the management capacities of local and national water supply entities. It also aims to improve the provision of technical and rural credit assistance to farmers.

Progress to Date

45,639 farmers have been trained in on-farm water management, exceeding the 45,000 target; 100% of the \$8.5 million credit fund has been disbursed to farmers; rehabilitation of 17 pumping stations and 5 gravity-fed irrigation systems is nearing completion; to date, 225 main canal structures have been completed and 49 kilometers of tertiary canal have been refurbished; and 25.7 of 28 kilometers of main canals have been rehabilitated.

Rural Road Rehabilitation Project

This project aimed at providing better access to economic and social infrastructure through upgrades and the rehabilitation of rural roads, audits of ongoing roads maintenance, and strategic plans for future road maintenance, but funding has not resumes, as stated above.

feasibility and design studies for more than 570 kilometers, which were later used by the World Bank to repair 170 kilometers of rural roads; 100% of 24 kilometers of roads have been improved; road roughness improved by 78%; average daily traffic increased to 735 (compared to target of 706); as a condition precedent, the Government passed legislation that qualified 2,700 key but minor roads for regular operations and maintenance; and Road links rehabilitated with MCC, World Bank, and Asian Development Bank funding are legally required

to be maintained by the Government.

Prior to MCC's decision not to resume funding for this project,

MCC rehabilitated 24 kilometers of road and completed



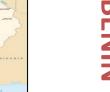

Compact Projects

Access to Markets Project

Through improvements at the Port of Cotonou, the project aims to improve performance and security, expand capacity, and reduce costs at the Port of Cotonou. Increased volume and reduced costs will benefit the entire Beninese economy.

Project Amount \$185.4 M

Progress to Date

Port volume increased on average 7% annually since 2006; waiting times for bulk ship carriers at port reduced from 7 to 5 days; Lot 1 (Jetty extension) completed; scheduling procedures recommended by MCC-financed Port Advisor cut costs for port customers; private sector concession management of the new wharf will provide over \$30 million in annual income; and improvements to security and customs in the port are underway.

Access to Land Project

This project is designed to strengthen property rights and investments by securing land tenure for the poor and non-poor alike and creating effective, transparent governance of land and property issues. This project is expected to increase land security and to reduce the time and cost to obtain a title.

Project Amount \$34.4 M

Field survey and census work for rural landholding plans completed in 280 villages; 82 village plans completed with controls and 43 have been delivered to the villages; registration of 28 urban zones, containing 30,000 individual parcels for titling, completed; 7 Global Navigation Satellite System stations constructed and in operation; and decree on the Declaration of National Policy for Landholding and the Domain adopted by the Council of Ministers along with 8 Decrees that implement the Rural Landholding Law of 2007.

Access to Justice Project

Improving the ability of the judicial system to enforce contracts and resolve claims will strengthen the institutional environment for business and investment in Benin. This project aims to increase the number of cases resolved per year, increase the number of cases treated by a local arbitration center, and decrease the time required to register an enterprise.

Project Amount \$23.9 M

100 magistrates and 60 court clerks trained; 239 businesses have accessed the arbitration center; business registration reduced from 39 to 5 days; more than 9,000 enterprises registered; 70% of firms reported increased confidence in the justice system; new code of civil, commercial, social and administrative procedures passed by the National Assembly; construction is underway on a Legal Information Center and 5 courts;

Access to Financial Services

A small grants program aims to improve the efficiency of micro, small and medium-sized enterprises by reducing costs and improving access to financial services. Reinforcement of regulatory capacity will also increase microfinance institutions' (MFIs') self-sufficiency, decrease MFIs' portfolios at risk, and increase loans guaranteed with land titles.

Construction is well underway on the N1 Highway and on the trunk roads; the first phase of rehabilitation of the floating dock has been completed; the hull for the first ferry is to be completed next quarter so that it can then be outfitted and construction of the second vessel can commence in the floating dock; work is progressing on the landings and terminals; Ghana's Millennium Development Authority has begun discussions with other donors regarding potential financial support for expanding the trunk and feeder roads program; and MCC is coordinating with the donor transportation roundtable in Ghana on policy related matters.

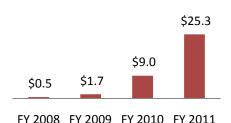

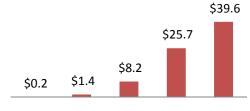

Industrial Park Project

Transition to High Value Agriculture Project

The project aims to repair up to 11 irrigation systems servicing 15,500 hectares, providing water for high value agriculture (HVA) and higher yielding grains. Technical assistance and capacity building will support the establishment of water user associations (WUA) which will be able to conduct operations and management (O&M) of the rehabilitated systems; enable the legal transfer of O&M responsibilities to WUAs; improve water resource management; and ensure the legal and institutional framework needed for irrigation sector sustainability and further future investments.

MCA-Moldova has conducted a launch ceremony for the Irrigation Sector Reform Activity in January 2010, that focused on community outreach strategies and the establishment of water user associations; communities and farm operators have demonstrated great interest in establishing water user associations that will be responsible for the operations and maintenance of the rehabilitated irrigation systems; the Government of Moldova amended a Water Law and passed a new Water User Association Law, two significant policy milestones; and on May 12, 2011, MCC and USAID signed an interagency agreement transferring responsibility to USAID for implementation of the Growing High Value Agriculture Sales Activity under the Transition to High Value Agriculture Project.

Road Rehabilitation Project

The project will rehabilitate 93 kilometers of the M2 and R9 roads between Sarateni to a major junction north of the city of Soroca. This highway is a link between Moldova and Ukraine for private and commercial travel, and a significant link for internal commerce and trade.

60 percent of the detailed design for the project has been accomplished to date; MCC's work with other international donors has helped promote the amendment of the Road Fund Law, which provides dedicated sources of funding for road maintenance; and MCC leveraged funds from multiple donors to provide a road safety assessment on 3,000 kilometers of roads.

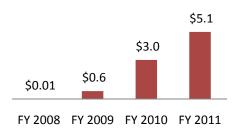

Property Rights

The project has two main components: urban and peri-urban. The urban component is improving the property registration system and helping poor households obtain title to urban land. The peri-urban component is leasing pastureland near cities to groups of herders and investing in infrastructure and training to improve livestock productivity and herder incomes.

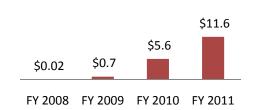

Health Project

The project seeks to strengthen the national program for prevention, early diagnosis and management of non-communicable diseases and injuries (NCDI) such as hypertension, diabetes, cervical and breast cancer and road traffic injuries. It addresses major causes and risks of NCDIs which cause premature adult death, disability and affect labor force productivity and the economic well being.

\$856,000 has been disbursed toward mobilization of civil society; capacity built for 3,794 heath workers; 120 small grants awarded to civil society and local government organizations; behavioral change communications underway; recommendations on road safety interventions finalized; grant to World Health Organization for stroke and heart attack component in place; and introduction of human papillomavirus vaccine and application for donated vaccines was submitted to Gardasil/Merck.



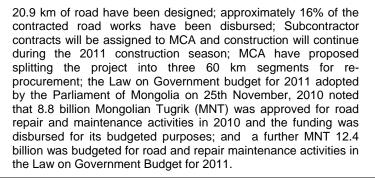

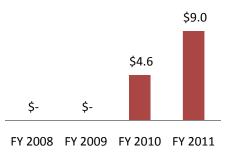
Rail Project

On April 27, 2009, the Government of Mongolia notified MCC that it intended to withdraw a rail project from the Compact. In January 2010, approximately \$188 million from such rail project was formally reallocated towards the expansion of the Health, Property Rights, and Education projects, and the addition of the new Road and Energy and Environment projects.

North-South Road Project *new project

The project is aimed at providing more efficient transport for trade and access to services by constructing 176.4km of all-weather road from Choir to Sainshand and a new 260m bridge with roadway approaches near the existing Bayanzurkh bridge along with the rehabilitation of the existing 252m Bayanzurkh bridge and 17.5km of existing road from Ulaanbaatar to Nalaikh.





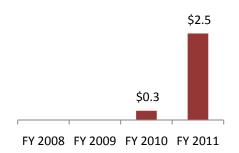

Energy and Environment Project *new project

The project is aimed at the sustainable reduction in air pollution in Ulaanbaatar through a comprehensive public awareness campaign; the creation of a facility to identify energy efficient technologies, evaluate benefits, and make available financial incentives so that such technologies can be more quickly adopted; and through ancillary network upgrades in support of the first on-grid commercial wind farm in Mongolia.

Indicators remain under development; subsidies have been disbursed for 2,089 ger insulation sets, 562 ger vestibules, and 9 energy efficient homes; the subsidy program, now including three stove models, will be scaling up beginning in May 2011 to cover six ger districts, including 48 khoroos or sub-districts comprising the Air Pollution Reduction Zone; MCA-Mongolia concluded an affordable energy efficient home design contest in February 2011 with over 40 domestic and international design submissions; sixteen grants totaling \$100,000 were awarded in May 2011 for greening of the ger districts; and studies are nearing completion for the replacement or refurbishment of up to 10 heat only boilers over the next year.

The Morocco Compact seeks to reduce poverty and stimulate economic growth through investments in five projects. These strategic investments will increase productivity and improve employment in high potential sectors such as fruit tree productivity, small-scale fisheries, and artisan crafts. Small Scale Fisheries Project

Artisan and Fez Medina Project

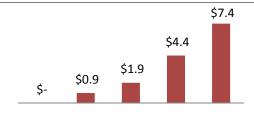

Enterprise Support Project

This project aims to reduce high unemployment among young university graduates and encourage a more entrepreneurial culture by measuring the impact of three pilot training initiatives being offered by the government; expanding training initiatives beginning in Year 4; and capacity building to help the government better manage the selection and training processes for entrepreneurs.

Coaching tailored to each enterprise is underway and will continue until at least September 2011; 672 days of coaching and training sessions were held from January through April; training completed for 3 Government of Morocco implementing entities, enabling them to complete enterprise diagnostics and oversee coaching of entrepreneurs; an information system allowing them to track progress has been designed and is being installed; and 6 forums hosted by Moroccan Government entity facilitated exchanges between Moukawalati entrepreneurs.

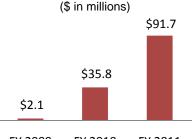
Transport Sector Project

Energy Sector Project

This project is to increase investment value added of businesses by: manufacturing and installing a new 100 megawatt submarine electric transmission cable from the mainland to Zanzibar; and rehabilitating the distribution infrastructure and 1600 kms of distribution line extensions to areas in six regions that have never before been linked to the national power grid.

Design-build contracts for the Zanzibar submarine power cable and associated overhead lines, distribution network extension, and substations are in progress; distribution works will start in May; in Kigoma, the feasibility study for the Stage III Malagarasi hydropower plant is underway, while designs for distribution network rehabilitation and extension have been finalized and those for a solar photovoltaic program are nearly complete; the Government passed a new Electricity Act to update 75-year old legislation, fulfilling a compact requirement; and its new provisions have created an environment more conducive for private sector participation and investment.

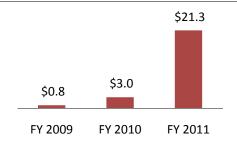

Water Sector Project

This project is to increase investment in human and physical capital and reduce the prevalence of water-related diseases through: expanding the capacity of the Lower Ruvu water treatment plant; rehabilitating water intake and water treatment plants; and improving the existing distribution network in the city of Morogoro.

Construction contracts for the expansion of the Lower Ruvu water treatment plant and rehabilitation/expansion of Morogoro water supply system were signed in December 2010 and January 2011; construction is now underway; and continued progress on the tariff and utility management reform in the water sector, required under the compact, is a significant safeguard that will contribute to institutional sustainability.

Progress to Date

Transportation Project
This project aims to increase tourism, business development, and agriculture production by upgrading 92.5 kilometers of the Efate Ring Road and 57.2 kilometers of the Santo East Coast Road by improving road sustainability through technical support and the provision of maintenance equipment for the Public Works Department.

The rehabilitation and sealing of 149.7 kilometers of roads are complete; as part of the Institutional Strengthening Activity, seven officers were hired for the new Engineering Support Unit within the Vanuatu Public Works Department (PWD); according to traffic counts from September 2010, the Efate Ring Road and Santo East Coast Road have exceeded the end-of-compact targeted increase in daily traffic by 331 percent and 117 percent, respectively; the roads are a shared endeavor which could not have happened without the effective coordination with the Government of New Zealand and Australia; an amendment to the Road Act and a Road Safety Campaign are being considered by the Government of Vanuatu; and PWD has approved \$1.6 million in the 2011 Business Plan for community-based routine road maintenance contracts to assist in upkeep and long-term sustainability.
