



## CONGRESSIONAL NOTIFICATION TRANSMITTAL SHEET

We wish to inform the Congress of our intent to adjust the fiscal years of funding used for the Millennium Challenge Compacts with the Republic of Indonesia and the Republic of Malawi.

The adjustments affect \$20,000,000 of the total \$600,000,000 Millennium Challenge Compact for the Republic of Indonesia and \$4,000,000 of the total \$350,700,000 Compact for the Republic of Malawi. The total amount of funds to be obligated will not change.

The attached notifications are being sent to Congress on October 25, 2012.

On October 20, 2011, the Millennium Challenge Corporation (“MCC”) notified the Congress of its intent to sign a Millennium Challenge Compact (“Compact”) with the Republic of Indonesia. In that notification, MCC advised that up to \$20,000,000 of fiscal year 2006 funds would be obligated for the Compact under section 605 of the Millennium Challenge Act of 2003, as amended (the “Act”).

In accordance with section 7015(c) and the heading “Millennium Challenge Corporation” of the Department of State, Foreign Operations, and Related Programs Appropriations Act, 2010, as carried forward by the Full-Year Continuing Appropriations Act, 2011, the notification of October 20, 2011, is hereby modified as follows: Of the amount intended to be obligated under section 605 of the Act when the Compact enters into force, the amount of fiscal year 2011 funds is increased by \$20,000,000 and the amount of fiscal year 2006 funds is decreased by \$20,000,000. Except as modified herein, the notification of October 20, 2011, remains unchanged.

On January 7, 2011, the Millennium Challenge Corporation (“MCC”) notified the Congress of its intent to sign a Millennium Challenge Compact (“Compact”) with the Republic of Malawi. In that notification, MCC advised that up to \$4,000,000 of fiscal year 2009 funds would be obligated for the Compact under section 605 of the Millennium Challenge Act of 2003, as amended (the “Act”).

In accordance with section 7015(c) and the heading “Millennium Challenge Corporation” of the Department of State, Foreign Operations, and Related Programs Appropriations Act, 2010, the notification of January 7, 2011, is hereby modified as follows: Of the amount intended to be obligated under section 605 of the Act when the Compact enters into force, the amount of fiscal year 2010 funds is increased by \$4,000,000 and the amount of fiscal year 2009 funds is decreased by \$4,000,000. Except as modified herein, the notification of January 7, 2011, remains unchanged.
