(U21). The topographic map depicts a solid blue line intersecting this wetland. During the site visit, the wetland boundary was identified and was determined to intersect the upper limit of a linear feature. However, this linear feature has non-hydric soils and dry leaf litter and debris in the bottom, and a road crossing with no culvert or drainage patterns was observed within the feature immediately northwest of the wetland. This linear feature does not have relatively permanent flow and does not provide a hydrologic connection for the on-site wetland. The wetland was determined to be surrounded by uplands with no other potential hydrologic connections observed. This wetland is a portion of a wetland that was previously determined to be isolated, non-jurisdictional in 1999 and 2006 (fka 87-99-0830 & 87-2004-1976).
