(U21). The topographic map depicts a solid blue line intersecting this wetland. During the site visit, the wetland boundary was identified and was determined to intersect the upper limit of a linear feature. However, this linear feature has non-hydric soils and dry leaf litter and debris in the bottom, and a road crossing with no culvert or drainage patterns was observed within the feature immediately northwest of the wetland. This linear feature does not have relatively permanent flow and does not provide a hydrologic connection for the on-site wetland. The wetland was determined to be surrounded by uplands with no other potential hydrologic connections observed. This wetland is a portion of a wetland that was previously determined to be isolated, non-jurisdictional in 1999 and 2006 (fka 87-99-0830 & 87-2004-1976). After the determination in 2006, the property owner filled in the southern portion of the wetland. Because of this information and the information obtained during the site visit, this wetland was determined to be a non-jurisdictional, isolated wetland .

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
