**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Area in review contained no Waters of the U.S. or isolated wetlands. Although the site is mapped as Lynn Haven, Leon, and Pocomoke soil series the site lacked sufficient hydrology to be determined a wetland. The site is completely encompassed by developed residential areas that include stormwater improvement drainage features that may have provided a historic alteration to hydrology. Its location adjacent to a major traffic corridor, residential development, and two college campuses and their associated stormwater plans seem to have impacted the infiltration and retention of water normally associated with sites comprised of these soil series. The site has been heavily manipulated by the recent reconfiguration of a road that bisected the property. The traffic diverted offsite onto University Boulevard for the purpose of creating a greenspace and frisbee golf course for the Coastal Carolina University students. What vegetation remained onsite was marginally facultative (*Quercus virginianus*) and is now dominated by ornamental grasses, shrubs, and trees.

Additionally, located onsite are several swales, excavated from uplands for the purpose of transporting stormwater off the newly constructed frisbee golf field that did not exhibit any jurisdictional features. Additionally, an upland excavated ditch forms the northeast property boundary and did not exhibit any jurisdictional features.
