**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: No wetlands or Waters of the US were observed during as site audit or after a review of available resources in the office. The site is a partially forested area and all soil samples contained no evidence of**

saturation greater than 24" from the soil surface. Additional field observation revealed high concentrations of uncoated sand grains with little to no organic matter in the upper 6" of the soil surface. Horry County Soil Survey information depicts the site as comprised Leon soils which are considered hydric. Horry NWI data depicts the site as U42P, an upland symbol and PSS1/4Bd (palustrine wetlands). USGS topographic maps (Nixonville Quad) depict a forested upland site. Two unpland excavated ditches create the north and south boundary of this property that did not exhibit any jurisdictional features. This site is located approximately 11,000 linear feet from the nearest jurisdictional tributary (Socastee Swamp).
