Explain: **Several blue lines are depicted on the topographic map within the review area, which usually indicates the presence of tributaries in these areas. However, no tributaries are depicted on the 1999 or 2006 aerials or the soil survey for Dillon County, which uses 1975 aerials. Additionally, no tributaries or other potential waters of the US**

were located during the site visit. A man-made upland excavated pond was observed during the site visit and determined to be non-jurisdictional.

The northern portion of the project area is depicted as having wetlands on the NWI map (PSS4Bd) and as having hydric soils in the soil survey (Coxville). Soil samples taken in this area during the site visit found no hydric soils were present. The vegetation in this area has been manipulated into a planted pine forest since prior to 1975, according to the Dillon Co. Soil Survey. Additionally, an expired jurisdictional determination (SAC-84-2005-1764) of the portion of this site located north of Countryside Road found no wetlands or other waters of the US within the project area.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Several blue lines are depicted on the topographic map within the review area, which usually indicates the presence of tributaries in these areas. However, no tributaries are depicted on the 1999 or 2006 aerials or the soil survey for Dillon County, which uses 1975 aerials. Additionally, no tributaries or other potential waters of the US were

located during the site visit. A man-made upland excavated pond was observed during the site visit and determined to be non-jurisdictional.

The northern portion of the project area is depicted as having wetlands on the NWI map (PSS4Bd) and as having hydric soils in the soil survey (Coxville). Soil samples taken in this area during the site visit found no hydric soils were present. The vegetation in this area has been manipulated into a planted pine forest since prior to 1975, according to the Dillon Co. Soil Survey. Additionally, an expired jurisdictional determination (SAC-84-2005-1764) of the portion of this site located north of Countryside Road found no wetlands or other waters of the US within the project area.
