**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** No wetlands were discovered using the 1987 Wetland Delineation Manual. The subject site is mapped with Goldsboro soils (not hydric) and Coxville, Noboco, and Norfolk (hydric) soils. Very little vegetation is present within the right of way, and vegetation is mostly upland grass species (cultivated). No hydrology was present within the review area. The entire review area is depicted on the NWI maps as U21 and U11, uplands. The site consists of upland areas, specifically existing roadway, shoulders, without the presence of roadside ditches. No features are depicted on USGS Quad maps. Soils within the right-of-ways were determined to be non-hydric. No waters of the US were discovered within the review area.
