**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. **ADDITIONAL COMMENTS TO SUPPORT JD:** Limits of the jurisdiction of wetlands were established by the 1987 Delineation Manual. A prevalence of hydrophytic vegetation and hydric soils were observed on the property but no hydrology indicators were encountered. The field investigation is consistent with available resources such as the NWI maps, USGS topo maps, infrared aerial photographs, and other available resources. No wetlands or streams are depicted or described by any of the available resources. A linear feature was reviewed within the review area. The linear feature had bed and banks, an OHWM, and flow of water within the bottom channel. The linear feature was investigated upstream of the property and no flow was witnessed. Furthermore, the linear feature was determined to be situated entirely in uplands, draining only uplands according to field investigation and available resources. No other potentially jurisdictional waters were discovered during the investigation.
