- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Gladdys Whiddon Park is a neighborhood recreational park of the City of Walterboro featuring a central ~1.1-acre freshwater pond derived from excavation of uplands (a 'borrow pit'). The pond appears in 1957 aerial photography, predating much of the current surrounding residential neighborhood. It is sited in mapped uplands with high-chroma soils, and shows a cut-bank profile that has been extensively bolstered with rip-rap. Its piped inlet does not drain any wetland areas above the park. The constructed outfall connects to an upland outfall conveyance that does not show compelling signs of flow such as sorting, scouring or any traces of an Ordinary High Water Mark. The topography of the outfall would lead about 0.3-mile south towards Ireland Creek but inspection of this path does not show evidence of recent or regular flow. The borrow pit acts as an upland stormwater detention pond for the surrounding neighborhood and is not a 'waters of the US'.**

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

Gladdys Whiddon Park is a neighborhood recreational park of the City of Walterboro featuring a central ~1.1-acre freshwater pond derived from excavation of uplands (a 'borrow pit'). The pond appears in 1957 aerial photography, predating much of the current surrounding residential neighborhood. It is sited in mapped uplands with high-chroma soils, and shows a cut-bank profile that has been extensively bolstered with rip-rap. Its piped inlet does not drain any wetland areas above the park. The constructed outfall high on the west bank connects directly to an upland outfall conveyance that does not show compelling signs of flow such as sorting, scouring or any traces of an Ordinary High Water Mark. The topography of the outfall would lead about 0.3-mile south towards Ireland Creek, but inspection of this path did not show evidence of recent or regular flow. The pond acts as an upland stormwater detention pond for the surrounding neighborhood (without a designed retention discharge structure). It is not a 'waters of the US', and not subject to Clean Water Act jurisdiction.
