C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area contains 0.755 acres of uplands. A portion of the lot, approximately 75-80 percent is a cleared grassed area. The remaining portion located adjacent to the western boundary is forested. This forested area was assessed as a potential wetland area; however, this area did not meet the criteria for a wetland as defined in the 1987 Wetland Delineation Manual and/or appropriate Regional Supplement. In addition, a review of the Corps' databases did not reveal that the potential wetland was part of any onsite mitigation for impacts associated with the previous Department of the Army Permit for a road crossing verified under SAC 14-99-0694.
