C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is a 0.36 acre non-developed residential lot. The project area was determined to be comprised totally of uplands. Potential wetlands were assessed within the project area; however, this area lacked indicators of hydric soils. Soil samples taken within the potential wetland area revealed that more than 30% of sand grains at the surface were uncoated; therefore, not meeting the requirements of any field indicators of hydric soils outlined in the “*Field Indicators of Hydric Soils in the United States*” guide published by NRCS, version 7.0 dated 2010.
