**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland boundaries established by the 1987 Wetland Delineation Manual. Wetland Q (150.80 acres) is contiguous with the OWHM of PRPW #3. The tributary was found to have flowing water at least 90% of the year under normal climatic conditions. The stream's geomorphic indicators of perennial flow were a firm sandy bottom free of vegetation and debris contained within a bed and bank system with the presence of a well defined OHWM. The streams hydrologic indicators were the open channel with evenly distributed substrates and water bars where leaves and debris are washed downstream by the constant flowing water even under drought conditions. A review of aerial photography and Horry County LIDAR topographic data depict a defined channel with bed and banks.**
