This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland boundaries established by the 1987 Wetland Delineation Manual. Wetlands K (74.38 acres), N (38.33 acres), O (1.32 acres), P (0.52 acres), Q (150.80 acres), and R (15.72 acres) contained a dominance of hydroptic vegetation, hydric soils, and saturation within the upper 12" of the soil surface under drought conditions. Flow of onsite tributary, PRPW #7, was determined to be at least 90% of the year under normal climatic conditions. Stream geomorphic indicators of perennial flow were channel within bed and banks had a firm sandy bottom clear of vegetation and debris, sediment bars located adjacent to the channel which is evidence of perennial flow as well as hydrologic indicators observed within the channel of leaves being continuously washed downstream and water flowing after 48 hours from a rainfall event. In addition, the tributary had a pronounced OWHM and contained aquatic fauna (minnows, tadpoles, etc). USGS topograph maps depict the named tributary, East Prong of Sterritt Swamp, as a solid blue line the indicator for perennial flow.**

**NOTE: PRPW #7 covered on this basis form originates as PRPW #6 at the confluence of the East Prong and South Prong of Sterritt Swamp located on the western portion of the property. At this position, PRPW #6 bisects wetland KK.**
