This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland boundaries established by the 1987 Wetland Delineation Manual.** The site is comprised of the named, tidally influenced tributary, Cowford Swamp. The tributary is represented by a solid blue line on USGS topographic maps and indicators of tidal influence, such as unvegetated mud flats and a falling tide was observed during the July 20, 2012 site visit. The wetlands onsite are bisected by the HTL/MHW of Cowford Swamp and are typical of bottom land hardwood swamps associated with major river systems in the Coastal Plain. Vegetation was dominantly fac wet or obligate, a mixture of surface saturation and inundation was present during the height of the growing season, and the Johnston soils were hydric. Additionally, separating Cowford Swamp and the adjacent wetlands from the upland areas was a well defined topographic break. The uplands onsite were dominated by Lakeland soils which are non-hydric (hydric only 2% of its mapped component), did not exhibit any signs of hydrology, and were dominated by a marginally facultative vegetation component (planted pines). Upland portions of the site are located on high sandy bluffs flanking the Greet Pee Dee River and its tributary Bull Creek.

Also located within the project area are portions of two non-jurisdictional / upland excavated ditches that did not exhibit any jurisdictional features.

This site was assessed on one basis form.
