the second one bisected the center of the parcel and served as a direct hydrologic connection for Wetland 1 and the downstream TNW via an onsite PRPW.

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. (iii) **Chemical Characteristics:**

Characterize tributary (e.g., water color is clear, discolored, oily film; water quality; general watershed characteristics, etc.).

Explain: **Water was relatively clear at the time of the site visit and contained iron oxidizing bacteria, an indicator of ground water interception.**

Identify specific pollutants, if known: **No known pollutants. However, the close proximity of the residential subdivisions provides potential for runoff such as oil, fertilizer, and other pollutants to enter the tributary.**

General watershed characteristics include 57.5% water, 18% urban land, 7.6% forested wetland, 6.6% forested land, 4.1% agricultural land, 3.6% scrub/shrub land, 1.4% nonforested wetland, and 1.2% barren land.**

Identify specific pollutants, if known: **There are no known pollutants. The wetland is surrounded by forested uplands which provide a buffer to the wetland. However, this site is surrounded by major highways and commercial and residential development creating the potential for some pollution runoff into the wetland.**

Characteristics (type, average width): **While the wetland is not truly a riparian, it does act as a buffer to the adjacent non-jurisdictional ditch which is a direct conduit to the downstream RPW and TNW. Explain: **Within the 30' plot size represented on the Data Sheets, vegetation consisted of: Tree stratum-Pinus taeda(5%); Sapling/Shrub stratum-Persea borbonia (50%), Morella cerifera (30%), Liquidambar styraciflua (10%), Magnolia virginiana (10%); Herb stratum-Lyonia lucida (70%), Persea borbonia (30%), Morella cerifera (5%), Liquidambar styraciflua (5%), and Sarracenia flava (yellow pitcherplant) (2%).**

Summarize overall biological, chemical and physical functions being performed: **: All wetlands evaluated in this significant nexus determination (SND) which are similarly situated and adjacent (both directly abutting and non-abutting) to the RPW are collectively performing biological, chemical, and physical functions. The wetlands in the review area are situated less than 1 river mile from the nearest TNW. Water discharging from the wetlands enter an onsite perennial RPW that flows directly Pawleys Island Creek. Water from the onsite wetland (Wetland 1) specifically flows into the PRPW by way of an upland excavated non-jurisdictional direct hydrologic connection. Wetlands 1 & 2 are mixed pine/hardwood depressional wetlands that provide breeding grounds and shelter for aquatic species, foraging areas for wetland dependent species, and spawning areas for species that inhabit the main channel as adults. These wetlands also provide organic carbon to the downstream tributaries and ultimately into the Atlantic Ocean, resulting in the nourishment of the downstream food web. The wetlands evaluated in this SND provide the important collective functions of removal of excess nutrients which are contributed by runoff from the surrounding urban areas. The wetlands reduce nitrogen and phosphorus loading downstream, and effectively prevent oxygen depletion that can result from eutrophication. The wetlands also collectively perform flow maintenance functions, including retaining runoff inflow and storing flood water temporarily.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland boundaries established by the 1987 Wetland Delineation Manual. This site consists of an approximately 0.40 acre jurisdictional freshwater wetlands. Wetland 1 is adjacent (non-abutting) an onsite perennial RPW which flows into Pawleys Island Creek, a named TNW. The tributary in combination with its adjacent wetlands have the capacity to carry pollutants or flood waters to the downstream TNW. They provide habitat and lifecycle support functions for fish and other species, such as feeding grounds, nesting, spawning, or rearing young for species that are present in the downstream TNW. The tributary in combination with its adjacent wetlands also have the capacity to transfer nutrients and organic carbon that support downstream foodwebs. This office has determined that there is a significant nexus for the tributary in combination with its adjacent wetlands to the downstream TNW.

The site in review contained two non-jurisdictional upland excavated ditches that did not exhibit any jurisdictional features. Along the southeastern portion of the property line was the first non-jurisdictional ditch while the second one bisected the center of the parcel and served as a direct hydrologic connection for Wetland 1 and the downstream TNW via an onsite PRPW.
