This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland boundaries are established using the 1987 Wetland Delineation Manual. The site is comprised entirely of Hobcaw soils which are hydric throughout their map unit. The site displayed strong hydrophytic vegetation, hydric soils (a predominance of coated sand grains), and hydrology throughout the wetland area. The wetland area contrasted the upland portion of the site by its lack of hydrology (friable soils, with dominantly uncoated sand grains) and marginal to upland vegetation.**

**Previous SND determination (Spectre LLC) dated November 1, 2010 included the wetland onsite and determined it to be jurisdictional and having a significant nexus to the downstream TNW, Collins Creek**

**The site was assessed on one basis form. .**
