C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Determination documented in SAC 2010-01044-3JH letter dated 12/13/2010, basis form 1 of 6. Documentation in SAC 2010-01044-3JH, Basis Form 1 of 6 describes tributary as follows: "Flow of onsite tributary was determined to be at least 90% of the year under normal climatic conditions. Stream geomorphic indicators of perennial flow were channel within bed and banks had a firm sandy bottom clear of vegetation and debris, sediment bars located adjacent to the channel which is evidence of perennial flow as well as hydrologic indicators observed within the channel of leaves being continuously washed downstream and water flowing after 48 hours from a rainfall event. In addition, other hydrologic indicators observed within the relevant reach of the stream were an even distribution of substrates (longitudinally) in the stream channel, evidence of groundwater discharge (Iron Oxidizing Bacteria) and flowing algae. In addition to site inspection other resources were reviewed which included Topographic maps, aerial photos, Horry County Soil Survey, and 1975 Horry County Drainage Study. Topographic maps do not depict a tributary; aerial photos depict signatures of a drainage feature; Horry County Soil Survey does not depict a tributary within this area where tributary is located".
